

## Amendment No. 76—

On page CJ 9-16 of the printed bill, Sec. 9-303(b), in line 3, strike out the word “TESTIF?” and insert in lieu thereof the word “TESTIFY”.

*Which amendment was read and adopted.*

## Amendment No. 77—

On page CJ 9-16 of the printed bill, Sec. 9-304(a), in line 11, after the word “ATTEND”, insert the word “AND”.

*Which amendment was read and adopted.*

## Amendment No. 78—

On page CJ 9-16 of the printed bill, Sec. 9-305, in line 31, strike the word “STATE” and in lieu thereof insert the word “STATES”.

*Which amendment was read and adopted.*

## Amendment No. 79—

On page CJ 10-1 of the printed bill, Sec. 10-102(a), in line 28, strike out the word “ONE” and insert in lieu thereof the word “ANY”.

## Amendment No. 80—

On page CJ 10-2 of the printed bill, Sec. 10-201(a), in line 33, strike out the word “LEGALIZED” and insert in lieu thereof the word “ADOPTED”; and on page CJ 10-3 of the printed bill, Secs. 10-201(b) and 10-201(c), lines 13 and 24 respectively, strike out the word “LEGALIZED” and insert in lieu thereof the word “ADOPTED”.

(1) THE PUBLIC LAWS, ORDINANCES, REGULATIONS, AND RESOLUTIONS APPROVED AND ENACTED BY A COUNTY OR MUNICIPAL CORPORATION OF THE STATE, THE MAYOR AND CITY COUNCIL OF BALTIMORE, THE MARYLAND NATIONAL CAPITAL PARK AND PLANNING COMMISSION, OR THE WASHINGTON SUBURBAN SANITARY COMMISSION, SHALL BE JUDICIALLY NOTICED OR READ IN EVIDENCE FROM THE PRINTED VOLUMES OR FROM A TRUE COPY OF AN AMENDMENT PUBLISHED BY THE AUTHORITY OF THE COUNTY OR MUNICIPAL CORPORATION.
