### (C) AFTER ADMINISTRATION.

AFTER THE ESTATE IS CLOSED, A CRECITOR WHOSE CLAIM HAS NOT BEEN BARRED MAY RECOVER DIRECTLY FROM THE PERSONS TO WHOM PEOPERTY HAS BEEN DISTRIBUTED AS PROVIDED IN §10-102, OR FROM A FORMER PERSONAL REFRESENTATIVE INDIVIDUALLY AS PROVIDED IN §10-103.

#### 8-102. EFFECT OF STATUTE OF LIMITATIONS.

## (A) GENERAL.

UNLESS A CONTRARY INTENT IS EXPRESSLY INDICATED IN THE WILL, A CLAIM WHICH WAS BARRED BY A STATUTE OF LIMITATIONS AT THE TIME OF THE DEATH OF THE DECEDENT MAY NOT BE ALLOWED OR PAID.

#### (E) EFFECT OF DEATH.

SUBJECT CT §8-103(A), A PERICD OF LIMITATIONS WHICH WOULD TERMINATE, EXCEPT FOR THE DEATH OF THE DECEDENT, DURING THE PERIOD FROM THE DEATH OF THE DECEDENT UNTIL SIX MONTHS AFTER THE DATE OF THE FIRST APPOINTMENT OF A PERSONAL REPRESENTATIVE, IS AUTOMATICALLY EXTENDED UNTIL SIX MONTHS AFTER THE DATE OF THE FIRST APPOINTMENT OF A PERSONAL REPRESENTATIVE.

#### 8-103. LIMITATION ON PRESENTATION OF CLAIM.

# (A) GENERAL.

EXCEPT AS OTHERWISE EXPRESSLY PROVIDED BY STATUTE WITH RESPECT TO CLAIMS OF THE UNITED STATES AND THE STATE, ALL CLAIMS AGAINST AN ESTATE OF A DECEDENT, WHETHER DUE OR TO BECOME DUE, ABSOLUTE OR CONTINGENT, LIQUIDATED OR UNLIQUIDATED, POUNDED ON CONTRACT, TORT, OR OTHER LEGAL BASIS, ARE FOREVER BARRED AGAINST THE ESTATE, THE FERSONAL REPRESENTATIVE, AND THE HEIRS AND LEGATEES, UNLESS PRESENTED WITHIN SIX MONTHS AFTER THE FIRST APPOINTMENT OF A PERSONAL REPRESENTATIVE.
