CHARTERED AND SUPERVISED AS A SAVINGS AND LCAN OR SIMILAR INSTITUTION UNDER FEDERAL LAW OR THE LAWS OF A STATE OR A PEDERAL CREDIT UNION OR A CREDIT UNION CHARTERED AND SUPERVISED UNDER THE LAWS OF A STATE: A "COMESTIC FINANCIAL INSTITUTION" IS ONE CHARTEFED AND SUPERVISED UNDER THE LAWS OF THIS STATE OR A BANK CHARTERED AND SUPERVISEC UNDER FEDERAL LAW AND HAVING ITS PRINCIPAL OFFICE IN THIS STATE: AN "INSURED FINANCIAL INSTITUTION" ONE, DEPOSITS (INCLUDING A SAVINGS, CERTIFICATE, OR DEPOSIT ACCOUNT) IN WHICH ARE, IN WHOLE OR IN PART, INSURED BY THE FEDERAL DEPOSIT INSURANCE CCRPORATION, THE FEDERAL SAVINGS AND LOAN INSURANCE CORPORATION, THE MARYLAND SAVINGS-SHARE INSURANCE CORPORATION OR A SIMILAR INSTITUTION ORGANIZED UNDER THE LAWS OF ANOTHER STATE.

(H) GUARDIAN.

A "GUARDIAN" OF A MINOR MEANS THE GENERAL GUARDIAN, GUARDIAN, TUTOR, OR CURATOR OF HIS FROPERTY OR ESTATE APPOINTED OF QUALIFIED BY A CCURT OF THIS STATE OR ANOTHER STATE.

(I) ISSUER.

AN "ISSUER" IS A PERSON WHO PLACES OF AUTHORIZES THE PLACING OF HIS NAME ON A SECURITY (CTHER THAN AS A TRANSFER AGENT) TO EVIDENCE THAT IT REPRESENTS A SHARE, PARTICIPATION OR OTHER INTEREST IN HIS EFOPERTY OR IN AN ENTERPRISE OR TO EVIDENCE HIS DUTY OR UNDERTAKING TO PERFORM AN OBLIGATION EVIDENCED BY THE SECURITY, OR WHO BECOMES RESPONSIBLE FOR OR IN PLACE OF ANY SUCH PERSON.

(J) LEGAL REPRESENTATIVE.

A "LEGAL REPRESENTATIVE" OF A PERSON IS HIS PERSONAL REPRESENTATIVE OR THE GENERAL GUARDIAN, GUARDIAN, COMMITTEE, CONSERVATOR, TUTCR, OR CURATOR OF HIS PROPERTY OR ESTATE.

(K) LIFE INSURANCE POLICY OR ANNUITY CONTRACT.

A "LIFE INSURANCE POLICY OR ANNUITY CONTRACT" MEANS A LIFE INSURANCE POLICY OR ANNUITY CONTRACT AS THOSE TERMS ARE CEFINED IN ARTICLE 48A OF THIS CODE, TITLE "INSURANCE," ISSUED BY AN INSURANCE COMPANY ON THE LIFE OF A MINCF TO WHOM A GIFT OF THE POLICY OR CONTRACT IS MADE IN THE MANNER PRESCRIBED IN THIS SUBTITLE OR ON THE LIFE OF A MEMBER OF THE MINOR'S FAMILY.

(I) MEMBER OF A MINOR'S FAMILY.

A "MEMBER" OF A "MINOF'S FAMILY" MEANS ANY OF THE MINOR'S PARENTS, GRANDPARENTS, BRCTHERS, SISTERS, UNCLES,
