SUBTITLE 5. MISCELLANEOUS PROVISIONS RELATING TO MINORS.

13-501. PAYMENT ON DELIVERY OF MONEY OR CHATTELS.

(A) METHOD OF PAYMENT.

ANY PERSON, INCLUDING BUT NOT LIMITED TO A PERSONAL REPRESENTATIVE OR TRUSTEE, WHO IS UNDER A DUTY TO PAY OR DELIVEE MONEY OR TANGIBLE PERSONAL PROPERTY TO A MINOR MAY PERFORM THE DUTY BY PAYING OR DELIVERING THE MONEY OR CHATTEL TO THE GUARDIAN OF THE MINCR. IF THERE IS NO GUARDIAN, OR IF HE IS UNKNOWN, PAYMENT OR DELIVERY IN AMOUNTS OR VALUES NOT EXCEEDING \$5,000 PER ANNUM [[SHALL]] MAY BE MADE TO THE PARENT OR GRANDPARENT OF THE MINOR WITH WHOM HE RESIDES. IF THERE IS NO GUARDIAN, PARENT, OR GRANDPARENT WITH WHOM THE MINOF RESIDES, PAYMENT OR DELIVERY IN AMOUNTS OR VALUES NOT EXCEEDING \$5,000 PER ANNUM [[SHALL]] MAY BE MADE TO A PARENT OR OTHER PERSON STANDING IN LCCO PARENTIS WITH THE MINOR, OR DEPOSITED IN A FINANCIAL INSTITUTION DESCRIBED IN §13-301(G)[[,]]. [[OR AS OTHERWISE]] [[ORDERED BY THE COURT.]] THE PAYOR IS NOT UNDER A DUTY TO INQUIRE WHETHER THE MINOR HAS A GUARDIAN.

(B) DEPOSIT IN FINANCIAL INSTITUTION.

A DEPOSIT IN A FINANCIAL INSTITUTION SHALL BE IN THE SOLE NAME OF THE MINOR. THE MINOR MAY NOT WITHDRAW ANY FUNDS WITHOUT AN ORDER OF COURT OR UNTIL HE ATTAINS HIS MAJORITY.

(C) OBLIGATIONS OF PERSONS RECEIVING FUNDS.

OTHER THAN THE MINOF CR A FINANCIAL INSTITUTION, A PERSON RECEIVING MONEY CR PROPERTY FOR A MINOF SHALL APPLY THE MONEY TO THE SUFPORT AND EDUCATION OF THE MINOF. HE MAY NOT PAY HIMSFLF EXCEPT FOR REIMBURSEMENT FOR OUT-OF-FOCKET EXPENSES FOR GOODS AND SERVICES FURNISHED BY OTHERS WHICH ARE NFCESSARY FOR THE SUPPORT OF THE MINOR. ANY EXCESS SUMS SHALL BE FRESERVED FOR FUTURE SUFFORT OF THE MINOR, AND ANY BALANCE NOT SO USED AND ANY TANGIBLE CHATTELS RECEIVED FOR THE MINOF SHALL BE TURNED OVER TO THE MINOF WHEN HE ATTAINS MAJOFITY.

(D) EFFECT OF RELEASE.

IF A PERSON OWES MONEY OR PROPERTY TO A MINOR AND
