- (2) EACH ISSUE OF THE REGISTER SHALL CONTAIN A TABLE OF CONTENTS AND AN INDEX OF ALL TITLES OF THE CODE OF MARYLAND REGULATIONS AFFECTED.
- (3) A CUMULATIVE INDEX SHALL BE PUBLISHED AT LEAST ONCE EVERY THREE MONTHS.
- (4) THE AELR COMMITTEE MAY PROVIDE FOR THE MORE PREQUENT PUBLICATION OF THE REGISTER AS CIRCUMSTANCES REQUIRE.
 - (D) OFFICIAL SYNOPSIS OF RULES.

THE AELR COMMITTEE MAY PERMIT AN OFFICIAL SYNOPSIS OF A RULE OR REGULATION IN THE REGISTER INSTEAD OF THE FULL TEXT [[IN ANY CASE WHERE]] IF THE FULL TEXT WILL BE PUBLISHED PURSUANT TO § 256G WITHIN 90 DAYS OF PUBLICATION OF THE OFFICIAL SYNOPSIS.

(E) NOTATION OF ADOPTED RULE SIMILAR TO PROPOSED RULE.

IF THE TEXT OF AN ADOPTED RULE IS SUBSTANTIALLY SIMILAR TO THE TEXT OF THE PROPOSED RULE, THE ADMINISTRATOR MAY INSERT IN THE REGISTER A NOTATION TO THIS EFFECT GIVING A REFERENCE TO THE DATE OF THE REGISTER CONTAINING THE PROPOSED RULE.

256G. PERMANENT SUPPLEMENTS TO OFFICIAL CODIFICATION; ANNOTATIONS.

(A) PERMANENT SUPPLEMENTS TO OFFICIAL CODIFICATION.

AT LEAST ONCE A YEAR, EVERY DOCUMENT REQUIRED TO BE COMPILED PURSUANT TO § 256C SHALL BE PERMANENTLY INTEGRATED INTO THE CODE OF MARYLAND REGULATIONS BY PUBLICATION OF LOOSELEAF PAGES OR OTHER APPROPRIATE PERMANENT SUPPLEMENTS OF THE CODE OF MARYLAND REGULATIONS. THE INDEX TO THE CODE OF MARYLAND REGULATIONS SHALL BE SIMILARLY SUPPLEMENTED OR REISSUED.

(B) ANNOTATIONS.

THE ADMINISTRATOR MAY PREPARE, OR PROCURE BY CONTRACT, AND INCLUDE IN THE PERMANENT SUPPLEMENTS ANNOTATIONS OF JUDICIAL DECISIONS AND OTHER EXPLANATORY MATERIAL RELATING TO ANY DOCUMENT PUBLISHED IN THE PERMANENT SUPPLEMENT.

256H. MATERIAL NOT PERMITTED TO BE PUBLISHED.
