

UNLESS OTHERWISE PROVIDED BY THE AELR COMMITTEE OR SPECIFIED IN THE ORDER ADOPTING THE DOCUMENT, ANY INCORPORATION BY REFERENCE OF ANY PORTION OF ANY OF THE FOLLOWING PUBLICATIONS SHALL OMIT THE TEXT OF THE INCORPORATED MATERIAL IN THE CODE OF MARYLAND REGULATIONS, PERMANENT SUPPLEMENTS, OR THE REGISTER:

- (1) ANNOTATED CODE OF MARYLAND,
- (2) UNITED STATES STATUTES AT LARGE,
- (3) UNITED STATES CODE,
- (4) SESSION LAWS,
- (5) CODE OF FEDERAL REGULATIONS,
- (6) FEDERAL REGISTER, OF
- (7) ANY OTHER GENERALLY AVAILABLE PUBLICATION SPECIFIED BY THE ADMINISTRATOR.

(B) NEWS RELEASES.

NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBTITLE, NO PRESS RELEASE, SPEECH, OTHER COMMENT, OR NEWS MATERIAL MAY BE PUBLISHED IN THE CODE OF MARYLAND REGULATIONS, PERMANENT SUPPLEMENTS, OR THE REGISTER.

256-I. DEPOSIT OF SUBSEQUENT DOCUMENTS.

(A) RULES AND REGULATIONS.

EXCEPT AS PROVIDED BY ART. 40, § ~~[[41]]~~ 40A, AT LEAST 60 DAYS PRIOR TO THE ADOPTION OF ANY RULE OR REGULATION BY ANY AGENCY, THREE CERTIFIED COPIES OF THE RULE OR REGULATION SHALL BE FILED WITH THE ADMINISTRATOR. THE ADMINISTRATOR IMMEDIATELY SHALL FORWARD TO THE AELR COMMITTEE ONE CERTIFIED COPY AND ANOTHER COPY SHALL BE TRANSMITTED TO THE PRINTER FOR PUBLICATION.

(B) EMERGENCY RULES AND REGULATIONS.

TWO CERTIFIED COPIES OF ANY EMERGENCY RULE OR REGULATION SHALL BE FILED WITH THE ADMINISTRATOR AS SOON AS IT IS EFFECTIVE. THE ADMINISTRATOR IMMEDIATELY SHALL TRANSMIT ONE COPY TO THE PRINTER FOR PUBLICATION.

(C) OTHER DOCUMENTS.

EXCEPT FOR EXECUTIVE ORDERS AND COURT RULES, TWO CERTIFIED COPIES OF EVERY OTHER DOCUMENT REQUIRED OR AUTHORIZED TO BE INCLUDED IN THE CODE OF MARYLAND REGULATIONS OR THE REGISTER SHALL BE FILED WITH THE
