

ADMINISTRATOR. THE SECRETARY OF STATE SHALL TRANSMIT TO THE ADMINISTRATOR TWO CERTIFIED COPIES OF EACH EXECUTIVE ORDER HE RECEIVES. THE CLERK OF THE COURT OF APPEALS SHALL TRANSMIT TO THE ADMINISTRATOR TWO COPIES OF EACH COURT RULE [[HE RECEIVES]] ADOPTED OR PERMITTED TO BE ADOPTED BY THE COURT OF APPEALS, AND TWO COPIES OF EVERY ADMINISTRATIVE ORDER OR MEMORANDUM ISSUED BY THE CHIEF JUDGE OF THE COURT OF APPEALS OR THE ADMINISTRATIVE OFFICE OF THE COURTS AND DIRECTED TO BE PUBLISHED BY THE CHIEF JUDGE. THE CHIEF CLERK OF THE DISTRICT COURT SHALL TRANSMIT TO THE ADMINISTRATOR TWO COPIES OF EACH RULE ADOPTED BY THE CHIEF JUDGE OF THE DISTRICT COURT.

(D) PUBLIC INSPECTION; COPIES TO HALL OF RECORDS.

WHEN FILED WITH THE ADMINISTRATOR, A CERTIFIED COPY OF EACH DOCUMENT IS AVAILABLE FOR PUBLIC INSPECTION AND SHALL BE RETAINED ONE YEAR AFTER PUBLICATION. EVERY DOCUMENT, EXCEPT EXECUTIVE ORDERS AND COURT RULES, SHALL BE DELIVERED TO THE HALL OF RECORDS COMMISSION.

256J. PUBLICATION OF INDIVIDUAL REGULATIONS.

THE CODE OF MARYLAND REGULATIONS AND PERMANENT SUPPLEMENTS SHALL BE PUBLISHED PURSUANT TO TYPOGRAPHICAL AND CONTRACTUAL ARRANGEMENTS WHICH ENSURE TO EVERY AGENCY AND COURT AN OPPORTUNITY TO PROCURE AT REASONABLE COST INDIVIDUALLY PRINTED PAMPHLET COPIES OF THE [[REGUALTIONS]] REGULATIONS AND RULES OF THE AGENCY PUBLISHED UNDER THE AUTHORITY OF THIS ACT. NO AGENCY REGULATION OR [[STATEMENT]] STATEMENT OF POLICY PUBLISHED IN THE CODE OF MARYLAND REGULATIONS OR PERMANENT SUPPLEMENT MAY BE RESET OR OTHERWISE REPRINTED AT PUBLIC EXPENSE ON A FORMAT DISTINCT FROM THAT OF THE CODE OF MARYLAND REGULATIONS WITHOUT A WRITTEN DETERMINATION BY THE AELR COMMITTEE THAT THE SPECIAL FORMAT IS NECESSARY FOR THE EFFECTIVE PERFORMANCE OF THE FUNCTIONS OF THE AGENCY.

256K. PRICING AND DISTRIBUTION.

(A) PRICING.

THE AELR COMMITTEE SHALL ESTABLISH [[GUIDLINES]] GUIDELINES FOR THE FIXING OF PRICES TO BE CHARGED FOR INDIVIDUAL COPIES OF OR A SUBSCRIPTION TO THE CODE OF MARYLAND REGULATIONS, PERMANENT SUPPLEMENTS, AND THE REGISTER. THE COMMITTEE MAY PROVIDE FOR VOLUME DISCOUNTS AND FOR THE FREE RECIPROCAL EXCHANGE OF PUBLICATIONS BETWEEN THE STATE AND OTHER [[FOREIGN]] JURISDICTIONS.
