federal tax lien, or filing and entering release or waiver of a federal tax lien—\$3:

- (6) For recording of proceedings in judicial records——\$3 per page;
- (7) For furnishing certificate of "no divorce"—\$2.50:
- (8) For furnishing a certified copy of the docket entries—\$2.50; [and]
 - (9) For certification of any court paper—\$1[.];
- (10) FOR RECORDING ANY INSTRUMENT IN THE FINANCING STATEMENT RECORDS \$3 PER PAGE AND IN ADDITION:
- (i) FOR INDEXING EACH NAME THAT APPEARS ON THE INSTRUMENT \$1 PER NAME; AND
- (ii) FOR THESE PURPOSES THE NAMES OF A HUSBAND AND WIFE SHALL BE COUNTED SEPARATELY; [[AND]]
- (11) FOR RECEIVING, FILING, AND INDEXING FROM THE DISTRICT COURT A NOTICE OF A LIEN, NOTICE OF SCIRE FACIAS, LIEN OF JUDGMENT, LIEN OF ATTACHMENT, OR MODIFICATION OF A LIEN OF ATTACHMENT EACH \$3; AND
- [[(11)]] $\underline{(12)}$ FOR RECORDING ANY OTHER INSTRUMENT REQUIRED TO BE RECORDED BY LAW, EXCEPT PAPERS REQUIRED TO BE RECORDED IN THE LAND OR CHATTEL RECORDS \$3 PER PAGE.
 - (C) OFFICIALS EXEMPT FROM FEES.

THE CLERK MAY NOT CHARGE ANY COUNTY OR BALTIMORE CITY ANY FEE PROVIDED BY THIS SUBTITLE, UNLESS THE COUNTY OR BALTIMORE CITY FIRST GIVES ITS CONSENT.

(D) FEES FOR OTHER SERVICES.

THE CLERK IS ENTITLED TO A REASONABLE FEE FOR PERFORMING ANY OTHER SERVICE THAT IS NOT ENUMERATED IN THIS SUBTITLE OR IN §§ 3-501 THROUGH 3-503 OF THE REAL PROPERTY ARTICLE OF THE CODE.

(E) PARTIES AGGRIEVED BY A FEE.

IF A PARTY IN A PROCEEDING FEELS AGGRIEVED BY ANY FEE PERMITTED UNDER THIS SUBTITLE OR BY §§ 3-501 THROUGH 3-503 OF THE REAL PROPERTY ARTICLE OF THE CODE, HE MAY REQUEST A JUDGE OF THAT CIRCUIT COURT TO DETERMINE THE REASONABLENESS OF THE FEE.
