(d) in Baltimore County,

- beginning with the term of the State's (1) Attorney who is elected to that position in 1970, the State's Attorney's salary shall be twenty-two thousand five hundred dollars (\$22,500) annually. [Beginning] SUBJECT TO THE PROVISIONS OF ARTICLE III, SECTION 35 OF THE CONSTITUTION OF MARYLAND, AND BEGINNING with the term of the State's Attorney who is elected to that position in 1974, the State's Attorney's salary shall be Inot less twenty-two thousand five than hundred dollars (\$22,500.00) annually 1 [FEQUAL TO THE SALARY PAID TO A JUDGE OF THE CIRCUIT COURT FOR BALTIMORE COUNTY AND SHALL BE ADJUSTED FROM TIME TO TIME IN ACCORDANCE WITH ANY ADJUSTMENTS MADE IN THE SALARY PAID TO THAT JUDGE]? THIRTY-TWO THOUSAND DOLLARS [[(\$32,000)]] \$35,000 ANNUALLY. THE STATE'S ATTORNEY SHALL SERVE FULL TIME AND MAY NOT ENGAGE IN THE PRIVATE PRACTICE OF LAW.
- The State's Attorney shall appoint two (2) deputy State's attorneys, each to have an annual salary f of not more than eighteen thousand five hundred dollars (\$18,500.00) I [FEQUAL TO THE SALARY PAID TO A JUDGE OF THE DISTRICT COURT FOR BALTIMORE COUNTY AND SHALL BE WITH ANY ADJUSTED FROM TIME TO TIME IN ACCORDANCE ADJUSTMENTS MADE IN THE SALARY PAID TO THAT JUDGE 17 OF TWENTY-FIVE THOUSAND DOLLARS [[(\$25,000)]] \$27,500; one of these deputy State's attorneys shall be designated deputy State's attorney of trial and administration, and the other deputy State's attorney shall be designated State's attorney of operations. The deputy State's attorneys are to perform such work as the State's Attorney may require, SHALL SERVE FULL-TIME, AND MAY ENGAGE IN THE PRIVATE PRACTICE OF LAW.

TIN LIEU OF APPOINTING TWO FULL-TIME DEPUTY STATE'S ATTORNEYS, THE STATE'S ATTORNEY MAY ELECT TO APPOINT EITHER ONE OR BOTH ON A PART-TIME BASIS. IF A PART-TIME DEPUTY STATE'S ATTORNEY IS APPOINTED, HE SHALL BE PAID 80% OF THE SALARY PAID TO A JUDGE OF THE DISTRICT COURT FOR BALTIMORE COUNTY, AND MAY ENGAGE IN THE PRIVATE PRACTICE OF LAW.]
