PROVIDED IN SUBSECTION (B).

VERIFICATION OF SIGNATURES AND CERTIFICATION. (B)

ANY PAPER WHICH IS PART OF A PETITION SHALL BE SUBMITTED TO THE BOARD OF THE COUNTY IN WHICH THE SIGNERS ON THE PAPER ARE ALLEGED TO RESIDE. THE BOARD SHALL GIVE A SIGNED RECEIPT TO THE PERSON SUBMITTING THE PAPER THAT THE PAPER IS FILED WITH THE BOARD. STATING BOARD SHALL VERIFY THE SIGNATURES OF ALLEGED PEGISTERED IN THAT COUNTY ACCORDING TO A METHOD PRESCRIBED BY THE FAIR CAMPAIGN FINANCING COMMISSION. POLLOWING VERIFICATION, AN AUTHORIZED EMPLOYEE OF THE BOARD SHALL STATE ON EACH PAPER THE NUMBER OF SIGNATURES VERIFIED BY THE EMPLOYEE, AND ENDORSE AND SIGN THE PAPER. THE CANDIDATE PROVIDED IN §4A-2, FOR DETERMINATION OF THE SUFFICIENCY OF THE PERCENTAGE OF REGISTERED VOTERS SHALL BE BY EACH COUNTY BOARD. PAPERS REQUIRED TO BE FILED WITH THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS PURSUANT TO §4A-2, AFTER VERIFICATION AND ENDORSEMENT AS PROVIDED IN THIS SUBSECTION, SHALL BE DELIVERED BY THE BOARD TO THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS NOT LESS THAN 70 BEFORE THE PRIMARY ELECTION. IN THIS CASE, THE DAYS ADMINISTRATIVE BOARD OF ELECTION LAWS STATE SHALL DETERMINE THE SUFFICIENCY OF THE PERCENTAGE OF REGISTERED THE COMMISSION SHALL INFORM EACH BOARD OF THE VOTERS. NUMBER OF SIGNATURES NECESSARY FOR A MINIMUM, MAXIMUM, OR PERCENTAGE OF THE MAXIMUM, PUBLIC CAMPAIGN DONATION.

(C) BOARD TO COMPLETE FORM.

ON FINDING SUFFICIENT SIGNATURES TO QUALIFY FOR DONATION, THE BOARD SHALL COMPLETE A FORM PROVIDED BY THE COMMISSION AND WHICH SHALL BE CERTIFIED BY A NOTARY THAT THE FORM WAS SIGNED IN HIS PRESENCE BY AN EMPLOYEE OF THE BOARD. THE FORM SHALL PROVIDE FOR THE:

- (1) NAME OF THE CANDIDATE;
- (2) OFFICE THE CANDIDATE SEEKS:
- (3) ELECTION DISTRICT OR AREA IN WHICH THE CANDIDATE IS STANDING FOR ELECTION:
- NAME OF THE BOARD VERIFYING THE (4) SIGNATURES:
- NUMBER OF VERIFIED SIGNATURES FILED WITH (5) THE BOARD: AND
- SIGNATURE AND TYPED NAME OF THE BOARD (6) EMPLOYEE COMPLETING THE FORM.
