(D) DELIVERY OF PAPERS TO A BOARD.

THE PAPERS SHALL BE DELIVERED TO A BOARD FOR VERIFICATION DURING THE WORKING HOURS OF THE BOARD ON THE LAST MONDAY THAT IS NOT LESS THAN 90 DAYS BEFORE THE DAY ON WHICH THE PRIMARY ELECTION IS TO BE HELD.

(E) INVALIDITY OF SIGNATURES.

THE FINDING BY A BOARD THAT THE SIGNATURE OF A PERSON IS INVALID ON A PAPER, AFFECTS THAT SIGNATURE ONLY AND DOES NOT AFFECT OR IMPAIR ANY OTHER PORTION OF THE PAPER OR PETITION.

(F) INSUFFICIENT SIGNATURES.

IF A BOARD FINDS THAT A PETITION CONTAINS AN INSUFFICIENT NUMBER OF VALID SIGNATURES TO QUALIFY FOR THE MINIMUM PUBLIC CAMPAIGN DONATION AS PROVIDED IN \$30-3(B), THE BOARD SHALL ACCORDINGLY INFORM THE COMMISSION ON A FORM SIMILAR TO THAT PROVIDED IN SUBSECTION (C) OF THE CANDIDATE'S FAILURE TO QUALIFY. THE COMMISSION SHALL ISSUE A STATEMENT TO THE CANDIDATE EXPLAINING WHY HE WAS DENIED THE REQUESTED DONATION AND SHALL INCLUDE A COPY OF THE BOARD'S FINDING.

(G) VOTER NOT LIMITED TO SIGNING A SINGLE PETITION.

A REGISTERED VOTER WHO RESIDES WITHIN THE AREA WHERE CANDIDATES ARE STANDING FOR ELECTION MAY SIGN THE INDIVIDUAL PETITIONS OF ANY NUMBER OF CANDIDATES.

30-5. FAIR CAMPAIGN FINANCING COMMISSION.

(A) COMPOSITION OF THE COMMISSION.

THE ADMINISTRATOR OF THE STATE ADMINISTRATIVE BOARD OF ELECTION LAWS OR HIS DESIGNEE SHALL SERVE THE COMMISSION IN AN ADVISORY CAPACITY. THE FAIR CAMPAIGN FINANCING COMMISSION CONSISTS OF FIVE MEMBERS APPOINTED AS FOLLOWS:

- (1) TWO APPOINTED BY THE GOVERNOR, ONE TO BE A MEMBER OF THE STATE'S PRINCIPLE MAJORITY POLITICAL PARTY AND ONE TO BE A MEMBER OF THE STATE'S PRINCIPLE MINORITY POLITICAL PARTY;
- (2) ONE APPOINTED BY THE PRESIDENT OF THE SENATE;
- (3) ONE APPOINTED BY THE SPEAKER OF THE HOUSE OF DELEGATES; AND
