- (4) ONE, WHO IS NOT A JUDGE, APPOINTED BY THE CHIEF JUDGE OF THE COURT OF APPEALS.
 - (B) CHAIRMAN.

THE COMMISSION SHALL ELECT ONE OF ITS MEMBERS CHAIRMAN.

(C) TERM OF OFFICE AND VACANCIES.

EACH COMMISSION MEMBER SHALL HOLD OFFICE FOR A TERM OF FOUR YEARS, CO-EXTENSIVE WITH THE TERM OF THE GOVERNOR, AND SHALL CONTINUE IN OFFICE UNTIL HIS RESPECTIVE SUCCESSOR IS APPOINTED. A VACANT POSITION ON THE COMMISSION SHALL BE FILLED PROMPTLY FOR THE UNEXPIRED TERM, BY THE AUTHORITY WHO APPOINTED THE MEMBER WHOSE POSITION IS TO BE FILLED. MEMBERS OF THE COMMISSION ARE ELIGIBLE FOR REAPPOINTMENT. WITHIN 30 DAYS FROM THE EFFECTIVE DATE OF THIS SUBTITLE, THE GOVERNOR, PRESIDENT, SPEAKER, AND THE CHIEF JUDGE OF THE COURT OF APPEALS SHALL APPOINT INITIAL MEMBERS TO THE COMMISSION, TO SERVE UNTIL THE THIRD WEDNESDAY OF JANUARY, 1979.

(D) PERSONS PROHIBITED FROM SERVING.

NO OFFICER OR EMPLOYEE OF THE STATE OR ANY OF ITS SUBDIVISIONS, OR CANDIDATE FOR PUBLIC OFFICE, MAY BE ELIGIBLE TO SERVE ON THE COMMISSION.

(E) ALLOWANCE, OFFICE, AND STAFF.

EACH MEMBER OF THE COMMISSION RECEIVES PER DIEM COMPENSATION AS PROVIDED IN THE BUDGET FOR EACH DAY ACTUALLY ENGAGED IN THE DISCHARGE OF THE MEMBER'S OFFICIAL DUTIES, AS WELL AS REIMBURSEMENT FOR ALL NECESSARY AND PROPER EXPENSES. THE OFFICE SHALL BE LOCATED IN ANNAPOLIS AND SHALL CONSIST OF STAFF AT SALARIES PROVIDED IN THE ANNUAL STATE BUDGET.

(F) MEETINGS.

MEETINGS OF THE COMMISSION ARE HELD AT THE CALL OF THE CHAIRMAN, OR ANY THREE MEMBERS. THREE MEMBERS CONSTITUTE A QUORUM AND THE CONCURRENCE OR AT LEAST THREE MEMBERS IS REQUIRED TO DISBURSE A SUM FROM THE FAIR CAMPAIGN FINANCING PUND OR TO ISSUE AN EXPLANATORY STATEMENT DENYING A PUBLIC CAMPAIGN DONATION.

30-6. DUTIES OF THE COMMISSION.

THE FAIR CAMPAIGN FINANCING COMMISSION SHALL:

(1) ADVISE THE COMPTROLLER IN THE COLLECTION OF THE FAIR CAMPAIGN TAX, MANAGEMENT OF THE FUND, AND
