

FOR OTHER SUFFICIENT CAUSE.

[[ (D) ]] (C) VACANCIES IN THE MEMBERSHIP OF THE BOARD SHALL BE FILLED FOR THE UNEXPIRED TERM BY APPOINTMENT BY THE GOVERNOR.

[[ (E) THE ]] (D) WITHIN 90 DAYS AFTER THE EFFECTIVE DATE OF THIS ACT, EACH BOARD SHALL ADOPT RULES AND REGULATIONS, NOT INCONSISTENT WITH THE CONSTITUTION OR LAWS OF THIS STATE, WHICH ARE NECESSARY FOR THE PROPER ADMINISTRATION OF ITS DUTIES UNDER THIS SUBTITLE. THE RULES AND REGULATIONS ISSUED BY EACH BOARD SHALL PROVIDE FOR SUBSTANTIALLY THE SAME PROCEDURES.

[[ (F) ]] (E) NO MEMBER OF THE BOARD MAY PARTICIPATE WITH RESPECT TO ANY MATTER COMING BEFORE THE BOARD IN WHICH THE MEMBER HAS AN INTEREST. NOR MAY ANY MEMBER OF THE BOARD PARTICIPATE WITH RESPECT TO ANY MATTER THAT ANY FIRM, CORPORATION, PARTNERSHIP OR ASSOCIATION WITH WHICH THE MEMBER IS ASSOCIATED OR HAS BEEN ASSOCIATED WITHIN THE LAST TWELVE MONTHS, HAS AN INTEREST.

231-0. CONTRACTS TO BE AWARDED ON COMPETITIVE BASIS.

[[ ALL PROCUREMENT AND AWARD OF CONTRACTS, CONSULTANT AGREEMENTS OR OTHER OBLIGATIONS IN EXCESS OF \$25,000 FOR ARCHITECTURAL AND ENGINEERING SERVICES [[ TO BE UTILIZED BY ANY USING AUTHORITY ]] SHALL BE AWARDED ON A COMPETITIVE BASIS AND SHALL INCLUDE EVALUATION OF BOTH TECHNICAL AND PRICE PROPOSALS FROM TWO OR MORE SUPPLIERS IN ACCORDANCE WITH THE RULES AND REGULATIONS ISSUED BY THE [[ PROFESSIONAL SERVICES EVALUATION BOARD. ]] BOARDS. IN MAKING THE AWARD ON A COMPETITIVE BASIS, NEITHER THE PRICE PROPOSAL NOR THE TECHNICAL PROPOSAL SHALL BE THE SOLE CRITERION]] IN ACCORDANCE WITH THE RULES AND REGULATIONS ISSUED BY THE BOARDS, ALL PROCUREMENT AND AWARD OF CONTRACTS, CONSULTANT AGREEMENTS OR OTHER OBLIGATIONS IN EXCESS OF \$25,000 FOR ARCHITECTURAL AND ENGINEERING SERVICES SHALL BE AWARDED ON A COMPETITIVE BASIS AND SHALL INCLUDE EVALUATION OF BOTH TECHNICAL AND PRICE PROPOSALS FROM TWO OR MORE FIRMS UNLESS THE BOARD DETERMINES IN WRITING, IN ACCORDANCE WITH SECTION 231-Q (B), THAT THE PROFESSIONAL SERVICES CANNOT BE SO COMPLETELY DEFINED AS TO LEND THEMSELVES TO THAT PROCEDURE. IN MAKING THE AWARD ON A COMPETITIVE BASIS, NEITHER THE PRICE PROPOSAL NOR THE TECHNICAL PROPOSAL SHALL BE THE SOLE CRITERION.

231-P. REVIEW OF [[ USING AUTHORITY'S ]] REQUEST TO PROCURE ARCHITECTURAL/ENGINEERING SERVICES AND AWARD OF CONTRACT.
