

Article 88A - State Department of Social Services  
 Section 32B  
 Annotated Code of Maryland  
 (1969 Replacement Volume and 1973 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section 11A be and it is hereby added to Article 52A - Juvenile Services, of the Annotated Code of Maryland (1972 Replacement Volume and 1973 Supplement) to read as follows:

Article 52A - Juvenile Services  
 11A.

THE STATE DEPARTMENT OF JUVENILE SERVICES SHALL PROVIDE FOR CARE, DIAGNOSIS, TRAINING, EDUCATION, AND REHABILITATION OF CHILDREN BY PLACEMENT IN GROUP HOMES AND INSTITUTIONS OPERATED BY NONPROFIT CHARITABLE CORPORATIONS AND SHALL REIMBURSE THESE CORPORATIONS FOR THE COST OF PROVIDING THE SERVICES AT [[A RATE OF \$600 PER MONTH PER CHILD]] APPROPRIATE MONTHLY RATES TO BE DETERMINED BY THE DEPARTMENT AS PROVIDED FOR IN THE BUDGET FOR THOSE HOMES AND INSTITUTIONS PROVIDING INTERMEDIATE SERVICES (AS DEFINED BY THE DEPARTMENT OF JUVENILE SERVICES)[[, AND \$700 PER MONTH PER CHILD]] AND FOR THOSE HOMES AND INSTITUTIONS PROVIDING FULL SERVICES.

SECTION 2. AND BE IT FURTHER ENACTED, That new Section 32B be and it is hereby added to Article 88A - State Department of Social Services, of the Annotated Code of Maryland (1969 Replacement Volume and 1973 Supplement) to read as follows:

Article 88A - State Department of Social Services

THE STATE DEPARTMENT OF EMPLOYMENT AND SOCIAL SERVICES SHALL PROVIDE FOR CARE, DIAGNOSIS, TRAINING, EDUCATION, AND REHABILITATION OF CHILDREN BY PLACEMENT IN GROUP HOMES AND INSTITUTIONS OPERATED BY NONPROFIT CHARITABLE CORPORATIONS AND SHALL REIMBURSE THESE CORPORATIONS FOR THE COST OF PROVIDING THE SERVICES AT [[A RATE OF \$600 PER MONTH PER CHILD]] APPROPRIATE MONTHLY RATES TO BE DETERMINED BY THE DEPARTMENT AS PROVIDED FOR IN THE BUDGET FOR THOSE SERVICES (AS DEFINED BY THE DEPARTMENT OF EMPLOYMENT AND SOCIAL SERVICES)[[, AND \$700 PER MONTH PER CHILD]] AND for those homes and institutions providing full services.
