

SEVEN MEMBERS, WHO SHALL SERVE FOR A TERM OF THREE YEARS. OF THE MEMBERS FIRST APPOINTED, ONE SHALL SERVE FOR A TERM OF ONE YEAR, THREE SHALL SERVE FOR A TERM OF TWO YEARS, AND THREE SHALL SERVE FOR A TERM OF THREE YEARS.

(B) A MEMBER SHALL BE APPOINTED FROM LISTS SUPPLIED TO THE COUNTY COMMISSIONERS BY SENIOR CITIZEN ASSOCIATIONS, RETIRED EMPLOYEE ASSOCIATIONS, AND OTHER CITIZEN GROUPS WHICH HAVE A RECORD OF SUPPORT FOR SENIOR CITIZENS. THE MEMBERSHIP SHALL INCLUDE INDIVIDUALS AND REPRESENTATIVES OF AGENCIES AND GROUPS IN THE COUNTY CONCERNED WITH PROBLEMS OF THE AGING. A MAJORITY OF THE MEMBERS SHALL BE OLDER RESIDENTS OF THE COUNTY.

(C) THE OFFICERS OF THE COMMISSION ARE CHAIRMAN, VICE CHAIRMAN, SECRETARY, AND TREASURER, EACH OF WHOM SHALL SERVE FOR A TERM OF ONE YEAR OR UNTIL THE NEXT ANNUAL MEETING OF THE COMMISSION. AN OFFICER MAY NOT SERVE FOR MORE THAN THREE CONSECUTIVE TERMS IN THE SAME OFFICE. OFFICERS SHALL BE ELECTED BY THE MEMBERS OF THE COMMISSION AT ITS ANNUAL MEETING OR WHEN A VACANCY OTHERWISE OCCURS.

(D) THE COMMISSION SHALL ADVISE AND ASSIST IN THE COORDINATION OF GOVERNMENTAL PROGRAMS; DEVELOP PUBLIC AND PRIVATE RESOURCES TO ALLOW FULL PARTICIPATION AFTER RETIREMENT; DEAL WITH MATTERS OF FINANCE, ORGANIZATION, SOCIAL SERVICES, HOUSING, EMPLOYMENT, LEISURE TIME, MEDICAL SERVICES, TRANSPORTATION, AND RETIREMENT INCOME AS THEY AFFECT THE SENIOR CITIZENS. IT MAY PARTICIPATE WITH OTHER COMMUNITY AND VOLUNTEER GROUPS TO FIND PART-TIME EMPLOYMENT; STIMULATE PERSONAL GROWTH AND SELF-WORTH THROUGH ADULT EDUCATION, LEADERSHIP, AND COMMUNITY SERVICES; AND ESTABLISH COOPERATIVE RELATIONSHIPS WITH COUNTY DEPARTMENTS, NON-OFFICIAL AGENCIES, STATE COMMISSION ON AGING, AND FEDERAL AGENCIES.

(E) THE COMMISSION MEMBERS SHALL SERVE WITHOUT COMPENSATION. THE COUNTY COMMISSIONERS SHALL BUDGET FUNDS FOR CLERICAL ASSISTANCE, STATIONERY, AND POSTAGE AS NECESSARY TO ASSIST THE COMMISSION IN THE NORMAL PERFORMANCE OF ITS DUTIES.

(F) THE COUNTY COMMISSIONERS MAY APPOINT TWO NON-VOTING ADVISORY MEMBERS TO THE COMMISSION WHO ARE REPRESENTATIVES OF SOCIAL AGENCIES INVOLVED IN SERVICES TO THE AGING AND WHO ARE NOT REGULAR MEMBERS OF THE COMMISSION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1974.
