SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section ~~[[2-501.1]] 6-602~~ be and it is hereby added to Article - ~~[[Courts and Judicial Proceedings]] 66 1/2~~, of the Annotated Code of Maryland ~~[[(1974 Volume)]]~~ 1970 Replacement Volume and 1973 Supplement to read as follows:

(A) ~~[[THE CLERK OF THE CIRCUIT COURT OF THE COUNTIES AND THE CLERK OF THE APPROPRIATE COURT OF THE SUPREME BENCH OF BALTIMORE CITY]]~~ NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBTITLE THE MOTOR VEHICLE ADMINISTRATION SHALL ISSUE, UPON REQUEST AND UPON PAYMENT OF A FEE OF \$5, AN IDENTIFICATION CARD TO ANY PERSON 18 YEARS OF AGE OR OVER WHO IS A RESIDENT OF [[SUCH COUNTY OR BALTIMORE CITY]] THIS STATE, UPON PRESENTATION OF PROOF OF AGE BY WAY OF A BIRTH CERTIFICATE AND SATISFACTORY PROOF OF IDENTITY IN A MANNER AND FORM AS PRESCRIBED BY THE ADMINISTRATOR.

(B) THE CARD, HEREINAFTER CALLED THE "AGE OF MAJORITY IDENTIFICATION CARD", SHALL ~~[[MEASURE 3 3/4 INCHES BY 2 1/2 INCHES AND BE LAMINATED OR OTHERWISE SUITABLY TREATED SO AS TO PROVIDE A TAMPER-PROOF COVERING]]~~ BE OF A SIZE AND DESIGN AS PRESCRIBED BE TAMPERPROOF TO THE EXTENT POSSIBLE. THE MAJORITY IDENTIFICATION CARD SHALL CONTAIN THE FOLLOWING INFORMATION:

- (1) NAME AND ADDRESS OF THE APPLICANT
- (2) BIRTH DATE OF APPLICANT (AS EVIDENCED BY BIRTH CERTIFICATE)
- (3) ~~[[FACE AND]]~~ SEX OF APPLICANT
- (4) DESCRIPTION OF APPLICANT ~~[[(TO INCLUDE HEIGHT, WEIGHT, COLOR OF HAIR, EYES AND COMPLEXION)]]~~
- (5) ~~[[PHOTOGRAPH OF APPLICANT TO BE SUPPLIED BY THE APPLICANT (MEASURING ONE BY ONE AND ONE-HALF INCHES)]]~~
