(1970 Replacement Volume and 1973 Supplement) to read as follows:

Article 66-1/2 - Vehicle Laws

NO PERSON RIDING UPON ANY COASTER, SKATEBOARD, ROLLER SKATES, SLED, OR TOY VEHICLE MAY ATTACH IT OR HIMSELF TO ANY VEHICLE UPON A ROADWAY.

SECTION 4. AND BE IT FURTHER ENACTED, That new Sections 18-101, 18-201 through 18-210, inclusive, 18-301 through 18-307, inclusive, and 18-401 through 18-404, inclusive, to be under the amended subtitle "Subtitle 18. Bicycles", be and they are hereby added to Article 66-1/2-Vehicle Laws, of the Annotated Code of Maryland (1970 Replacement Volume and 1973 Supplement) to read as follows:

Article 66-1/2 - Vehicle Laws

[Subtitle 18. Records and Reports of Convictions]

SUBTITLE 18. BICYCLES

18-101.

FOR THE PURPOSES OF THIS SUBTITLE:

- (A) "BICYCLE" MEANS EVERY DEVICE PROPELLED EXCLUSIVELY BY HUMAN POWER UPON WHICH ONE OR MORE PEOPLE MAY RIDE, HAVING TWO OR MORE TANDEM WHEELS, ONE OF WHICH IS 14 INCHES OR GREATER IN DIAMETER.
- (B) "OWNER" MEANS ANY PERSON, CORPORATION, PARTNERSHIP, OR OTHER LEGAL ENTITY OR INDIVIDUAL OR GROUP OR COMBINATION OF INDIVIDUALS WHICH ACTUALLY OWNS A BICYCLE, EXCEPT THAT IN THE CASE OF A PERSON UNDER THE AGE OF 18 YEARS WHO IS THE ACTUAL OWNER OF A BICYCLE, HIS PARENTS, GUARDIAN OR OTHER PERSON WHO IS REQUIRED TO OR DOES IN FACT, REGISTER THE BICYCLE UNDER THIS SUBTITLE IS DEEMED ITS OWNER.
- (C) "SERIAL NUMBER" MEANS THE NUMBER APPIXED ON A BICYCLE FRAME BY ITS MANUFACTURER.
- (D) "REGISTRATION NUMBER" MEANS THE NUMBER ISSUED BY THE DEPARTMENT PURSUANT TO THE REGISTRATION REQUIREMENTS OF THE SUBTITLE.
- (E) "OPERATE" MEANS TO PROPEL A BICYCLE BY HUMAN POWER OR TO WALK OR STAND WITH OR OTHERWISE BE IN CONTROL OF A BICYCLE INCIDENTAL TO ITS PROPULSION, BUT DOES NOT
