

(A) NO BICYCLE MAY BE OPERATED ON ANY HIGHWAY WHERE THE SPEED LIMIT IS IN EXCESS OF 50 M.P.H. UNLESS THE OPERATOR HAS A VALID DRIVER'S LICENSE ISSUED PURSUANT TO SUBTITLE 6 OF THIS ARTICLE.

(B) NO BICYCLE SHALL BE OPERATED ON ANY HIGHWAY DESIGNATED AS PART OF THE INTERSTATE SYSTEM, EXCEPT AS PROVIDED IN SECTION 11-1403.

18-206.

NO PERSON OPERATING A BICYCLE MAY ATTACH IT OR HIMSELF TO ANY OTHER VEHICLE WHICH IS IN MOTION.

18-207.

NO PERSON MAY OPERATE A BICYCLE WHICH DOES NOT CONFORM TO THE STANDARDS OF AND CONTAIN ALL EQUIPMENT REQUIRED BY REGULATIONS PROMULGATED BY THE DEPARTMENT.

18-208.

NO PERSON MAY REMOVE, RIDE UPON OR TAMPER WITH ANY BICYCLE OR PART THEREOF EXCEPT WITH THE PERMISSION OF ITS OWNER.

18-209.

NO PERSON MAY:

(1) THROW ANY OBJECT FROM A MOVING VEHICLE WHICH OBJECT STRIKES A BICYCLIST OR INTERFERES WITH A BICYCLIST'S VISION OR CONTROL OVER HIS BICYCLE, WITHOUT REGARD TO WHETHER THE PERSON THROWING THE OBJECT INTENDS TO STRIKE, INJURE OR INTERFERE WITH THE BICYCLIST;

(2) THROW ANY OBJECT AT OR IN THE DIRECTION OF ANY BICYCLIST OR OPEN THE DOOR OF ANY MOTOR VEHICLE WITH INTENT TO STRIKE, INJURE OR INTERFERE WITH A BICYCLIST OR TO OBSTRUCT OR INTERFERE WITH THE VISION OR CONTROL OF ANY BICYCLIST; OR

(3) DO ANY OTHER ACT INTENDED TO OBSTRUCT OR INTERFERE WITH A BICYCLIST'S VISION OR CONTROL OVER HIS BICYCLE.

18-210.

IT IS UNLAWFUL AND A MISDEMEANOR FOR ANY PERSON TO DO ANY ACT FORBIDDEN OR FAIL TO PERFORM ANY ACT REQUIRED BY THIS SUBTITLE.

18-301.
