

(A) EVERY BICYCLE OWNED OR IN THE POSSESSION OF A RESIDENT OF THIS STATE WHICH HAS ONE WHEEL 26 INCHES OR GREATER IN DIAMETER AND WHICH IS OR IS INTENDED TO BE USED IN ANY PUBLIC BICYCLE AREA SHALL BE REGISTERED UNDER THIS PART EXCEPT:

(1) BICYCLES OWNED BY OR IN THE POSSESSION OF A REGISTERED DEALER FOR PURPOSES OF SALE, OR

(2) AS OTHERWISE PROVIDED IN THIS SUBTITLE.

(B) EVERY OTHER BICYCLE IN THIS STATE WHICH IS NOT REQUIRED TO BE REGISTERED PURSUANT TO SUBSECTION (A) MAY BE REGISTERED UNDER THIS PART AT THE OPTION OF THE OWNER.

18-302.

IT IS UNLAWFUL AND A MISDEMEANOR FOR ANY PERSON TO OPERATE IN ANY PUBLIC BICYCLE AREA, ANY BICYCLE WHICH IS REQUIRED TO BE REGISTERED PURSUANT TO SECTION 20-301, SUBSECTION (A), AND WHICH IS NOT REGISTERED.

18-303.

(A) EVERY OWNER OF A BICYCLE SUBJECT TO REGISTRATION SHALL MAKE APPLICATION TO THE DEPARTMENT FOR THE REGISTRATION OF THE BICYCLE, PROVIDE ALL INFORMATION REQUIRED BY THE DEPARTMENT FOR ENFORCEMENT OF THE PROVISIONS OF THIS SUBTITLE, AND PAY THE APPLICABLE REGISTRATION FEES.

(B) IF A BICYCLE IS OWNED BY AN INDIVIDUAL UNDER THE AGE OF 18 YEARS, THE APPLICATION SHALL BE MADE JOINTLY BY THE OWNER AND A PARENT, GUARDIAN OR OTHER RESPONSIBLE ADULT.

18-304.

THE DEPARTMENT MAY CHARGE REASONABLE REGISTRATION FEES, NOT TO EXCEED THE PRO RATA COST OF ENFORCING THE PROVISIONS OF THIS SUBTITLE. IN ESTABLISHING THE FEES, THE DEPARTMENT MAY MAKE REASONABLE CLASSIFICATIONS OF REGISTRANTS AND BICYCLES, AND CHARGE DIFFERENT FEES THEREFOR, BASED UPON SUCH FACTORS AS THE VALUE OF THE BICYCLE, THE AGE OF THE OWNER, AND OTHER RELEVANT CRITERIA.

18-305.

(A) THE DEPARTMENT SHALL FILE EACH APPLICATION RECEIVED AND IF SATISFIED AS TO ITS GENUINENESS AND REGULARITY AND THAT THE APPLICANT IS ENTITLED TO THE ISSUANCE OF REGISTRATION, SHALL REGISTER THE BICYCLE THEREIN DESCRIBED AND KEEP A RECORD THEREOF IN A MANNER
