PERMITTING IDENTIFICATION OF THE BICYCLE AND OWNER.

- UPON REGISTERING A BICYCLE, THE DEPARTMENT SHALL ISSUE (I) A REGISTRATION CARD WHICH SHALL BE DELIVERED TO THE OWNER AND SHALL CONTAIN THE DATE ISSUED. THE NAME AND ADDRESS OF THE OWNER, THE REGISTRATION NUMBER ASSIGNED TO THE BICYCLE AND A DESCRIPTION OF THE BICYCLE AS DETERMINED BY THE DEPARTMENT, AND (II) A REGISTRATION TAB WHICH SHALL BE DELIVERED TO THE OWNER AND SHALL HAVE DISPLAYED UPON IT THE REGISTRATION NUMBER ASSIGNED TO THE VEHICLE BICYCLE.
- PENDING ACTION UPON THE APPLICATION. (C) DEPARTMENT MAY ISSUE TEMPORARY REGISTRATION CARDS AND TABS PERMITTING THE OPERATION OF A BICYCLE FOR WHICH APPLICATION FOR REGISTRATION HAS BEEN MADE, IF THE APPLICATION IS ACCOMPANIED BY THE PROPER FEE.

- (A) THE REGISTRATION OF A BICYCLE IS VALID FOR SO LONG AS THERE IS NO CHANGE IN ITS OWNERSHIP OR OTHER MATERIAL MATTER AFFECTING ITS REGISTRATION.
- THE DEPARTMENT MAY PROVIDE BY REGULATION OTHER REQUIREMENTS RELATING TO REGISTRATION. TRANSFER REGISTRATION AND OTHER MATTERS TO CONFORM, INSOFAR AS IS NECESSARY AND POSSIBLE, WITH THE PROVISIONS PROCEDURES OF SUBTITLE 3 OF THIS ARTICLE.

- THE OWNER OF ANY REGISTERED BICYCLE SHALL HAVE THE REGISTRATION TAB APPIXED TO THE FRAME OF THE BICYCLE.
- IT IS UNLAWFUL AND A MISDEMEANOR FOR ANY PERSON TO TRANSFER, REMOVE, DEFACE OR MUTILATE ANY VALID REGISTRATION TAB OR SERIAL NUMBER AFFIXED TO A BICYCLE OR TO CHANGE OR ALTER ANY REGISTRATION CARD FOR A BICYCLE.

EVERY BICYCLE SOLD OR RENTED SHALL CONFORM TO THE STANDARDS OF THE FEDERAL HAZARDOUS SUBSTANCES ACT (15 U.S.C.A. §§ 1261 ET SEQ.), ANY REGULATIONS PROMULGATED THEREUNDER AND ALL OTHER APPLICABLE FEDERAL LAWS, AND SHALL BE IN SAFE MECHANICAL CONDITION, AND SHALL CONFORM ALL OTHER SAFETY REQUIREMENTS, AS PROVIDED IN REGULATIONS PROMULGATED BY THE DEPARTMENT PURSUANT TO THIS SUBTITLE.
