pipe, thence crossing U.S. Route 40A, and running thence with the southern marginal line of a gravel farm lane North $78^{\circ} 58' 40''$ East 283.05 feet to an iron pipe, thence leaving said farm lane and running with the eastern marginal line of a 12 foot alley and the western boundary of the Thrift Loan Corporation property South $24^{\circ} 53' 10''$ East 1707.96 feet to an iron pipe, a corner of the Joseph Moser tract, thence with said tract and along the western boundary of the L.A. Summers and Son subdivision North $27^{\circ} 20' 50''$ East 274.06 feet to an iron pipe, thence with the boundary between Joseph Moser and Herschel Dean North $15^{\circ} 59' 48''$ East 594.32 feet to an iron pipe, thence crossing the Herschel Dean Tract in line with the school entrance's northern curb face South $69^{\circ} 02' 17''$ East 681.02 feet to a railroad spike on line with the northern curb face of the school entrance and on the northern boundary of the existing corporate limits and on the eastern marginal line of Maryland Route 66, thence with said marginal line South $17^{\circ} 53' 23''$ West 220.13 feet to an iron pipe, thence leaving said marginal line and running with the Washington County Board of Education tract South $72^{\circ} 58' 37''$ East 210.00 feet to a survey marker, thence with six lines of said tract South $21^{\circ} 38' 23''$ West 463.28 feet to an iron pipe, thence South $17^{\circ} 42' 00''$ West 78.86 feet to a survey marker, thence South $21^{\circ} 53' 29''$ West 147.21 feet to an iron pipe, thence South $16^{\circ} 24' 12''$ West 132.99 feet to a survey marker, thence North $86^{\circ} 37' 48''$ West 100.33 feet to an iron pipe, thence North $74^{\circ} 29' 34''$ West 96.75 feet to an iron pipe on the southeastern margin of Maryland Route 66, thence crossing Maryland Route 66, and also crossing the aforementioned L.A. Summer and Sons subdivision South $67^{\circ} 21' 28''$ West 907.90 feet to an iron pipe on the eastern boundary of Graystone Hills Section 3, thence with said boundary North $25^{\circ} 57' 00''$ West 629.33 feet to an iron pipe, a corner of lots 60 and 61 of said Section 3, thence with said boundary North $64^{\circ} 03' 00''$ West 150.00 feet to an iron pipe, thence crossing Della Lane South $25^{\circ} 47' 00''$ West 61.30 feet to an iron pipe, thence South $64^{\circ} 03' 00''$ West 425.00 feet to the place of beginning. Containing 82.01 acres of land, more or less. Being all that portion of land lying to the north and west of the corporate boundary of the Town of Boonsboro which is intended to be annexed to said town.
