EACH OF THE JUDGES OF THE COURT FOR CHARLES COUNTY SHALL RECEIVE AS ANNUAL COMPENSATION \$600. EACH JUDGE SHALL ALSO BE ALLOWED \$300 ANNUALLY FOR TRAVELING EXPENSES, PAYABLE QUARTERLY.

(K) DORCHESTER COUNTY.

EACH OF THE JUDGES OF THE CCURT FOR DOBCHESTER COUNTY SHALL RECEIVE AN ANNUAL SALARY IN THE AMOUNT OF \$900. EACH JUDGE SHALL ALSO RECEIVE AN ALLOWANCE OF \$10 FOR EXPENSES FOR EVERY DAY'S ATTENDANCE UPON THE SESSIONS OF THE COURT.

(1) FBEDERICK COUNTY.

EACH OF THE JUDGES OF THE COURT FOR PREDERICK COUNTY SHALL RECEIVE AN ANNUAL COMPENSATION OF \$2,000 WITH NO ADDITIONAL ALLOWANCE FOR EXPENSES.

(M) GABRETT COUNTY.

EACH OF THE JUDGES OF THE COURT FOR GARRETT COUNTY SHALL RECEIVE ANNUAL COMPENSATION IN THE AMOUNT OF \$600, TOGETHER WITH AN ALLOWANCE OF FIVE CENIS PER MILE FOR EACH MILF TRAVELED IN ATTENDING THE SESSIONS OF THE COURT.

(N) HASFORD COUNTY.

EACH OF THE JUDGES OF THE COURT FOR HARFORD COUNTY SHALL RECEIVE THE SUM OF \$15 FOR EVERY DAY'S ATTENDANCE UPON THE SESSIONS OF THE COURT. EACH JUDGE SHALL ALSO RECEIVE AN [[ALLOWNACE]] ALLOWANCE FOR TRAVELING EXPENSES OF \$250 ANNUALLY, TO BE FAID QUARTERLY BY THE COUNTY COUNCIL OF HARFORD COUNTY.

(O) HOWARD COUNTY.

EACH JUDGE OF THE COURT FOR HOWARD COUNTY SHALL RECEIVE AN ANNUAL COMPENSATION OF \$1,200 TO BE PAID MCNTHLY. EACH JUDGE SHALL ALSO RECEIVE AN EXPENSE ALLOWANCE, IN ADDITION, UP TO \$50 PER MCNTH, FOR PERSONAL EXPENSES INCIDENTAL TO HIS DUTIES, TO BE PAID BY THE TREASURER OF HOWARD COUNTY EACH MONTH UPON PRESENTATION OF AN ITEMIZED VOUCHER.

(P) KENT COUNTY.

THE CHIEF JUDGE OF THE COURT FOR KENT COUNTY SHALL RECEIVE AS HIS SOLE COMPENSATION, WITH NO ADDITIONAL ALLOWANCE FOR EXPENSES, THE SUM OF \$19.50 FOR EVERY DAY'S ATTENDANCE UPON THE SESSIONS OF THE COURT. EACH ASSOCIATE JULGE SHALL RECEIVE AS HIS SCLE COMPENSATION, WITH NO ADDITIONAL ALLOWANCE FOR EXPENSES, THE SUM OF \$17
