Section 13-300.2

(9A) BURLESQUE HOUSES OR THEATRES. ANY STRUCTURE USED FOR THEATRICAL ENTERTAINMENT [[IN]] WHICH FEATURES "LIVE STRIP TEASE" ACTS, [[DANCING]] OR ANY LIVE PERFORMANCE [FOR PART THEREOF]] WHICH [[CONSISTS OF]] CREATES AN ACT OR ILLUSION OF DISROBING.

(57A) MASSAGE PARLOR. ANY STRUCTURE HOUSING A BUSINESS FOR THE PURPOSE OF MANIPULATION, RUBBING, STROKING, KNEADING OR TAPPING OF BODY TISSUES FOR REMEDIAL OR HYGENIC PURPOSES, EITHER WITH THE HAND OR AN INSTRUMENT BY A PERSON OF THE OPPOSITE SEX, EXCLUDING PHYSICAL THERAPISTS, OSTEOPATHS, CHIROPRACTORS, OR ANY LICENSED PHYSICIAN.
