

ANNE ARUNDEL COUNTY

WHICH RESPONDS TO FIVE HUNDRED ONE (501) TO ONE THOUSAND (1,000) CALLS ANNUALLY.

(C) SEVENTY-FIVE (75) CALLS FOR A COMPANY WHICH RESPONDS TO ONE THOUSAND ONE (1,001) TO ONE THOUSAND FIVE HUNDRED (1,500) CALLS ANNUALLY.

(D) ONE HUNDRED (100) CALLS FOR A COMPANY WHICH RESPONDS TO MORE THAN ONE THOUSAND FIVE HUNDRED (1,500) CALLS ANNUALLY.

(7) A VOLUNTEER WHO IS REQUIRED TO SERVE FULL TIME EXTENDED OBLIGATORY MILITARY SERVICE IN THE ARMED FORCES OF THE UNITED STATES SHALL BE CONSIDERED ON MILITARY LEAVE. DURING THE PERIOD SERVED ON ACTIVE MILITARY DUTY, SAID VOLUNTEER SHALL RECEIVE ACTIVE VOLUNTEER SERVICE CREDIT OF FIFTY (50) POINTS FOR EACH FULL YEAR, PRORATED FOR SERVICE OF LESS THAN A FULL YEAR.

SECTION 10-307

IN ORDER TO PROVIDE CREDIT FOR SERVICE PRIOR TO JANUARY 1, 1970, EACH COMPANY SHALL REVIEW ITS MEMBERSHIP ROSTER TO DETERMINE THE NUMBER OF YEARS OF CREDIT TO WHICH EACH MEMBER IS ENTITLED. IN MAKING SAID ANALYSIS, THE STANDARDS FOR ACTIVE SERVICE SHALL BE USED AS GUIDELINES. APPROVAL FOR SUCH PRIOR SERVICE SHALL BE CERTIFIED BY THE CHIEF AND THE BOARD OF DIRECTORS OF THE INDIVIDUAL COMPANY. IF A VOLUNTEER MEMBER REQUESTS CREDIT FOR SERVICE IN MORE THAN ONE (1) COMPANY, EACH COMPANY SHALL PROVIDE THE ABOVE CERTIFICATION. IN THE EVENT THAT SUFFICIENT RECORDS ARE UNAVAILABLE TO PROVE SERVICE PRIOR TO JANUARY 1, 1970, THE CERTIFICATION SHALL BE MADE ONLY AFTER THOROUGH INVESTIGATION, AND ON THE BEST INFORMATION, KNOWLEDGE AND BELIEF OF THE CHIEF AND BOARD OF DIRECTORS OF THE INDIVIDUAL COMPANY.

SECTION 10-308

SAID PROGRAM SHALL BE FUNDED AS MAY FROM TIME TO TIME BE PROVIDED IN THE ANNUAL BUDGET.

SECTION 2. AND BE IT FURTHER ENACTED, That notwithstanding the provisions of Section 10-303 (b) of this Subtitle, for the calendar year 1973, the Board of Directors of each volunteer fire company shall submit its statement to the Board of Trustees of the Anne Arundel County Volunteer Firemen's Association by October 1st; the Board of Trustees of the Anne Arundel County Volunteer Firemen's Association shall furnish a copy thereof and certification of accuracy to the Controller by November 1st; and the Controller shall forward the
