

COUNTY LOCAL LAWS

(A) IN ADDITION TO THE REQUIRMENTS OF SECTION 1002A (A) (3) OF THE CHARTER EACH PERSON HOLDING AN OFFICE SET FORTH IN SECTION 1-902 ABOVE SHALL FILE WITH THE SECRETARY TO THE COUNTY COUNCIL ON OR BEFORE THE FIFTEENTH (15TH) DAY OF APRIL OF EACH YEAR DURING HIS OR HER TERM IN OFFICE, THE STATEMENT REQUIRED BY THIS SUBTITLE, FOR THE CALENDAR YEAR IMMEDIATELY PRECEDING EACH SUCH YEAR IN OFFICE.

(B) EXCEPT FOR A PERSON WHO HAS FILED A STATEMENT PURSUANT TO SUBSECTION (A) ABOVE FOR THE SAME PERIOD FOR WHICH A STATEMENT OTHERWISE WOULD BE REQUIRED TO BE FILED BY THIS SUBSECTION, EACH CANDIDATE FOR NOMINATION FOR, OR ELECTION TO, COUNTY EXECUTIVE OR COUNTY COUNCIL SHALL FILE WITH THE SECRETARY TO THE COUNTY COUNCIL AT THE SAME TIME THAT PERSON'S CERTIFICATE OF CANDIDACY IS FILED, THE STATEMENT REQUIRED BY THIS SUBTITLE, FOR THE SIX (6) MONTHS IMMEDIATELY PRECEDING THE YEAR IN WHICH THE CERTIFICATE OF CANDIDACY IS FILED.

(C) IF SAID CANDIDATE FAILS TO FILE SAID STATEMENT AFTER WRITTEN NOTICE BY THE SECRETARY TO THE COUNTY COUNCIL OF HIS OBLIGATION, GIVEN AT LEAST TWENTY (20) DAYS PRIOR TO THE LAST DAY FOR THE WITHDRAWAL OF CANDIDACY, HE SHALL BE DEEMED TO HAVE WITHDRAWN HIS CANDIDACY.

(D) THE LOCAL BOARDS OF ELECTION SUPERVISORS SHALL NOT ACCEPT ANY CERTIFICATE OF CANDIDACY OR CERTIFICATE OF NOMINATION UNLESS A STATEMENT IN PROPER FORM HAS BEEN FILED. WITHIN THIRTY (30) DAYS OF THE RECEIPT OF A STATEMENT, THE SECRETARY TO THE COUNTY COUNCIL SHALL FORWARD IT TO THE LOCAL BOARDS OF ELECTION SUPERVISORS.

(E) ALL STATEMENTS FILED PURSUANT TO THIS SUBTITLE SHALL BE MAINTAINED BY THE SECRETARY TO THE COUNTY COUNCIL AND SHALL BE MADE AVAILABLE DURING NORMAL OFFICE HOURS, FOR EXAMINATION AND COPYING BY THE PUBLIC, SUBJECT, HOWEVER, TO SUCH REASONABLE FEES AND ADMINISTRATIVE PROCEDURES AS THE DIRECTOR OF PURCHASING MAY ESTABLISH FROM TIME TO TIME. ALL STATEMENTS SHALL BE RETAINED AS PUBLIC RECORDS FOR AT LEAST TWO (2) YEARS FROM THE DATE OF THEIR RECEIPT BY THE SECRETARY TO THE COUNTY COUNCIL.

(F) THE SECRETARY TO THE COUNTY COUNCIL SHALL PROVIDE FORMS FOR USE IN THE FILING OF THE STATEMENTS REQUIRED BY THIS SUBTITLE TO THE PERSONS REQUIRED TO FILE STATEMENTS UNDER THIS SUBTITLE. THE SECRETARY TO THE COUNTY COUNCIL SHALL REQUIRE THAT ANY PERSON EXAMINING OR COPYING SUCH STATEMENTS SHALL RECORD HIS NAME, HOME ADDRESS, AND THE NAME OF THE PERSONS WHOSE DISCLOSURE STATEMENT WAS EXAMINED OR COPIED.
