

ESTABLISHMENT OF RULES AND REGULATIONS AND PROCEDURES FOR THE IMPLEMENTATION OF THESE PROGRAMS.

(B) AUTHORIZATION TO ESTABLISH - IN GENERAL.

EACH PUBLIC AND PRIVATE AGENCY MAY ESTABLISH RULES AND REGULATIONS AND PROCEDURES AS IT DETERMINES TO BE NECESSARY TO ASSURE:

(1) THAT THE PAYMENTS AND ASSISTANCE AUTHORIZED BY THIS SUBTITLE ARE ADMINISTERED IN A MANNER WHICH IS FAIR AND REASONABLE, AND AS UNIFORMLY AS FEASIBLE;

(2) THAT A DISPLACED PERSON WHO MAKES PROPER APPLICATION FOR A PAYMENT, AUTHORIZED FOR THE PERSON BY THIS SUBTITLE, IS PAID PROMPTLY AFTER A MOVE OR, IN HARDSHIP CASES, IS PAID IN ADVANCE; AND

(3) THAT ANY PERSON AGGRIEVED BY A DETERMINATION AS TO ELIGIBILITY FOR A PAYMENT, AUTHORIZED BY THIS SUBTITLE, OR THE AMOUNT OF A PAYMENT, MAY HAVE HIS APPLICATION REVIEWED BY THE AGENCY HAVING AUTHORITY OVER THE APPLICABLE PROGRAM OR PROJECT.

(C) SAME - CARRYING OUT PROVISIONS OF SUBTITLE AND FEDERAL STATUTE.

EACH PUBLIC AGENCY AND PRIVATE AGENCY, WHERE APPLICABLE, MAY ADOPT RULES, REGULATIONS, AND PROCEDURES, CONSISTENT WITH THE PROVISIONS OF THIS SUBTITLE AND THE FEDERAL "RELOCATION ASSISTANCE AND REAL PROPERTY ACQUISITION ACT OF 1970," PUBLIC LAW 91-646 AND RULES AND REGULATIONS ISSUED PURSUANT TO IT, AS IT DEEMS NECESSARY OR APPROPRIATE TO CARRY OUT THE PROVISIONS OF THIS SUBTITLE AND THE FEDERAL ACT.

(D) COMPLIANCE WITH OTHER PROVISIONS OF CODE.

ALL RULES AND REGULATIONS ADOPTED PURSUANT TO THIS SUBTITLE, EXCEPT THOSE ADOPTED PURSUANT TO §12-205, SHALL COMPLY WITH THE STATE ADMINISTRATIVE PROCEDURE ACT. THIS SUBSECTION DOES NOT APPLY TO RULES AND REGULATIONS ADOPTED BY BALTIMORE CITY, OR ANY OF ITS AGENCIES OR DEPARTMENTS.

(E) AUTHORITY OF BALTIMORE CITY TO ADMINISTER FEDERALLY FUNDED PROJECTS.

NOTWITHSTANDING ANY PROVISION OF THIS TITLE, BALTIMORE CITY, OR ANY OF ITS AGENCIES OR DEPARTMENTS RESPONSIBLE EITHER IN WHOLE OR IN PART FOR THE ADMINISTRATION OF ANY PUBLIC PROJECT, FUNDED EITHER IN WHOLE OR IN PART BY FEDERAL FUNDS, INCLUDING URBAN
