

## COUNTY LOCAL LAWS

SERVICE, COMMUTER RAIL SERVICE, AIRPARKS AND LANDING FIELDS, AND RELATED MATTERS.

(I) MAINTENANCE AND OPERATION OF TRANSPORTATION EQUIPMENT AND OTHER RELATED EQUIPMENT AS ASSIGNED.

(J) SUBDIVISION DEVELOPMENT, INCLUDING APPURTENANT STORM DRAINAGE SYSTEMS AND APPROVAL OF SUBDIVISION PLANS, AS PRESCRIBED BY LAW.

Sec. 7. A new Section 2-16H, Chapter 2, title "Administration," subtitle "Office of Facilities Management and Services," is hereby added to the Montgomery County Code 1965, as amended, to read as follows:

2-16H. OFFICE OF FACILITIES MANAGEMENT AND SERVICES.

THERE IS HEREBY ESTABLISHED AN OFFICE OF FACILITIES MANAGEMENT AND SERVICES UNDER THE IMMEDIATE DIRECTION OF A DIRECTOR WHO SHALL BE APPOINTED BY THE COUNTY EXECUTIVE SUBJECT TO CONFIRMATION BY THE COUNTY COUNCIL. THE OFFICE OF FACILITIES MANAGEMENT AND SERVICES SHALL HAVE THE FOLLOWING FUNCTIONS AND ACTIVITIES:

(A) MAINTENANCE OF BUILDINGS AND GROUNDS.

(B) PRINTING AND CENTRAL DUPLICATING.

(C) COMMUNICATIONS (EXCLUDING FIRE/RESCUE DISPATCH OPERATIONS).

(D) PROPERTY MANAGEMENT, INCLUDING BUILDING CUSTODIAL SERVICES, SECURITY, WAREHOUSING, EMPLOYEE FOOD SERVICES, AND LEASING.

Sec. 8. A new Section 2-16I, Chapter 2, title "Administration," subtitle "References to 'Director' and 'Director, Department of Public Works,'" is hereby enacted to read as follows:

2-16I. REFERENCES TO "DIRECTOR" AND "DIRECTOR, DEPARTMENT OF PUBLIC WORKS."
