discretion to borrow upon the full faith and credit of Prince George's County in any one year a sum not to exceed fifty thousand dollars (\$50,000.00) is furthered authorized to pay the proceeds of said sum or so much thereof as the said board deems advisable to the Prince George's General Hospital to offset wholly or in part the difference between the amount provided in the budget by the county commissioners and the operating deficit.]

- (c) Firemen and policemen. The said board of directors shall make provision for emergency treatment at the hospital without charge, of Prince George's County Volunteer Firemen and Prince George's County and municipal policemen, injured in the line of duty but shall make the usual charge for subsequent treatment which may be required.
- ENTERPRISE FUND. THE PRINCE GEORGE'S GENERAL (D) HOSPITAL. BEING SELF-SUSTAINING FUBLIC SERVICE A ENTERPRISE, IS EXPRESSLY RECOGNIZED AS BEING FUNDED OPERATED AS AN ENTERPRISE FUND AND THAT NO PART OF ANY SUMS AUTHORIZED TO BE APPROPRIATED FOR EXPENDITURE AT PRINCE GEORGE'S GENERAL HOSPITAL SHALL BE WITHHELD BY ANY OFFICER OR EMPLOYEE IN THE EXECUTIVE BRANCH OF THE COUNTY GOVERNMENT, EXCEPT SUCH SPECIFIC SUMS AS MAY BE DETERMINED BY THE OFFICE OF BUDGET AND PROGRAMMING, AFTER CONSULTATION WITH THE HOSPITAL ADMINISTRATOR, WHICH ARE NECESSARY TO BE WITHHELD FROM OBLIGATION FOR SPECIFIC PERIODS OF TIME TO ASSURE THAT SUFFICIENT AMOUNTS WILL BE AVAILABLE IN THE HOSPITAL FUND TO DEFRAY EXPENDITURES WILL BE REQUIRED TO BE MADE FROM SUCH FUND. FUNDS AUTHORIZED TO BE APPROPRIATED FROM THE HOSPITAL ENTERPRISE FUND SHALL BE EXPENDED BY OR ON BEHALF OF ANY COUNTY AGENCY OR DEPARTMENT OTHER THAN THE PRINCE GEORGE'S GENERAL HOSPITAL.
