

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Sections 12(g-1), 12(g-2), 12(g-3) and 27AE be and they are hereby added to Article 77A - Higher Education, of the Annotated Code of Maryland (1969 Replacement Volume and 1973 Supplement) to read as follows:

Article 77A - Higher Education

12.

(G-1) ANY STUDENT WHO IS ENROLLED IN OR WHO GRADUATES IN ACADEMIC YEAR 1973-1974 FROM A STATE COLLEGE UNDER THE TUITION WAIVER PROGRAM AUTHORIZED IN SUBSECTION (G), AND WHO HAS EXECUTED A CONTRACT TO TEACH IN THE PUBLIC SCHOOLS PURSUANT THERETO, MAY FULFILL HIS OBLIGATION TO THE STATE IN THE FOLLOWING MANNER:

(1) BY TEACHING IN A PUBLIC OR APPROVED NONPUBLIC ELEMENTARY OR SECONDARY SCHOOL, OR COLLEGE, IN MARYLAND FOR THE TERM AND WITHIN THE PERIOD SPECIFIED IN HIS CONTRACT; OR

(2) BY ENGAGING IN A [[FULL-TIME]] TEACHING, TRAINING OR [[OTHER]] EDUCATION POSITION EQUIVALENT TO A FULL-TIME TEACHING POSITION IN THE PUBLIC SCHOOLS OF MARYLAND WITH (A) A PUBLIC ELEMENTARY OR SECONDARY SCHOOL[[, OR COLLEGE]], IN ANY STATE WHICH IS PARTY TO THE INTERSTATE AGREEMENT ON QUALIFICATION OF EDUCATIONAL PERSONNEL, (B) A LICENSED DAY CARE CENTER IN MARYLAND, (C) ANY AGENCY OF THE STATE OF MARYLAND OR A POLITICAL SUBDIVISION OF THE STATE, [[OR]] (D) AN APPROVED VOCATIONAL OR TECHNICAL SCHOOL IN MARYLAND, OR (E) AN AGENCY OF THE FEDERAL GOVERNMENT, FOR THE TERM AND WITHIN THE PERIOD SPECIFIED IN HIS CONTRACT.

(G-2) THE BOARD OF TRUSTEES MAY, AS TO ANY STUDENT GRADUATING IN OR AFTER ACADEMIC YEAR 1973- 1974:

(1) DEFER COMMENCEMENT OF A TUITION WAIVER CONTRACT OBLIGATION FOR THE FIRST SCHOOL YEAR AFTER GRADUATION UPON A SHOWING THAT (A) THE STUDENT HAS MADE A BONA FIDE EFFORT TO OBTAIN AN EMPLOYMENT NECESSARY TO FULFILL HIS OBLIGATION, (B) HE HAS NOT BEEN ACCEPTED FOR SUCH EMPLOYMENT, AND (C) HE HAS BEEN REFUSED SUCH EMPLOYMENT BY AT LEAST FOUR LOCAL SCHOOL BOARDS IN MARYLAND;

(2) EXCUSE ONE-HALF OF THE STUDENT'S CONTRACTUAL LIABILITY UPON A SHOWING THAT WITHIN ONE YEAR AFTER GRADUATION, (A) THE STUDENT HAS MADE A BONA FIDE EFFORT TO OBTAIN AN EMPLOYMENT NECESSARY TO FULFILL HIS OBLIGATION, (B) HE HAS NOT BEEN ACCEPTED FOR SUCH EMPLOYMENT, AND (C) HE HAS BEEN REFUSED SUCH EMPLOYMENT
