

EFFICIENT ADMINISTRATION OF THE PROSECUTORIAL SYSTEM, PERSONNEL AND BUDGETARY MATTERS, AND CURRENT DEVELOPMENTS IN THE CRIMINAL LAW AND ITS ENFORCEMENT.

(H) IN THE INVESTIGATION AND PROSECUTION OF ANY CASE, HE HAS ALL THE POWERS OF A STATE PROSECUTOR. HOWEVER, HE MAY NOT CHARGE A PERSON BY WAY OF INFORMATION, BUT MAY PROCEED TO TRIAL ONLY UPON INDICTMENT BY A GRAND JURY.

(I) HE SHALL SUBMIT AN ANNUAL REPORT TO THE GOVERNOR, AND THE GENERAL ASSEMBLY ON THE ACTIVITIES OF HIS OFFICE AND THE OFFICES OF THE STATE PROSECUTORS, TOGETHER WITH ANY RECOMMENDATIONS HE DEEMS ADVISABLE.

(J) HE AND THE ATTORNEYS ON HIS STAFF SHALL DEVOTE FULL TIME TO THEIR OFFICIAL DUTIES AND SHALL NOT ENGAGE IN THE PRIVATE PRACTICE OF LAW.

(K) HE SHALL REPRESENT THE STATE IN ALL APPEALS AND POST CONVICTION PROCEEDINGS ARISING FROM PROSECUTIONS CONDUCTED BY HIM. HOWEVER, HE MAY REQUEST THE ASSISTANCE OF THE ATTORNEY GENERAL IN ANY SUCH APPEAL OR COLLATERAL PROCEEDING.

33C. STAFF

THE CHIEF STATE PROSECUTOR MAY APPOINT AND EMPLOY THE PROFESSIONAL, INVESTIGATIVE, AND CLERICAL STAFF PROVIDED IN THE STATE BUDGET. TO THE EXTENT PRACTICABLE, THE CHIEF STATE PROSECUTOR SHALL UTILIZE THE SERVICES AND PERSONNEL OF THE MARYLAND STATE POLICE AND OTHER ESTABLISHED STATE AND LAW ENFORCEMENT AGENCIES. THESE AGENCIES SHALL, TO THE EXTENT FEASIBLE, COOPERATE WITH THE CHIEF STATE PROSECUTOR AND HIS STAFF.

33D. VENUE OF TRIALS

THE TRIAL OF ALL CASES PROSECUTED BY THE CHIEF STATE PROSECUTOR PURSUANT TO § 33B(B) AND (D) SHALL TAKE PLACE BEFORE THE CIRCUIT COURT FOR ANNE ARUNDEL COUNTY, SUBJECT TO REMOVAL IN ACCORDANCE WITH THE MARYLAND RULES.

SECTION 2. AND BE IT FURTHER ENACTED, That new Sections 33E and 33F to be under the new subtitle "Prosecutors Disabilities Commission" be and they are hereby added to Article 10 - Attorneys at Law and Attorneys in Fact, of the Annotated Code of Maryland (1968 Replacement Volume and 1974 Supplement) to read as follows:
