TRAINING, AND DEMONSTRATIONS ON A REIMBURSABLE BASIS FOR OTHER PUBLIC AND PRIVATE AGENCIES:

- (9) FIX TUITION FOR STUDENTS ATTENDING THE UNIVERSITY;
- (10) FIX PEES, IN ADDITION TO TUITION, PAID BY RESIDENT AND NONRESIDENT STUDENTS, AND APPROPRIATE THE RECEIPTS FROM THE PEES FOR THE PURPOSE FOR WHICH THE FEE WAS COLLECTED WITHOUT FISCAL YEAR LIMITATION;
- (11) SELECT AND APPOINT A PRESIDENT OF THE UNIVERSITY AND DEANS OF THE UNITS OF THE UNIVERSITY, AND APPROVE THE APPOINTMENT OF OTHER OFFICERS;
- (12) PROCURE TEMPORARY AND INTERMITTENT SERVICES TO THE SAME EXTENT AUTHORIZED, BUT AT DAILY RATES FOR INDIVIDUALS NOT IN EXCESS OF THE AUTHORIZED MAXIMUM DAILY RATE OF THE TITLE:
- (13) DEVELOP AND DEFINE A POLICY FOR THE UNIVERSITY AND ESTABLISH THE MECHANISMS TO ENSURE ITS ENFORCEMENT;
- (14) PERFORM OTHER DUTIES NECESSARY TO CARRY OUT THE PURPOSES OF THE AUTHORIZATION.
- (D) THE BOARD, WITH APPROVAL OF THE GOVERNOR, MAY ACCEPT ANY DONATION, GIFT, GRANT, BEQUEST OR DEVISE FROM ANY INDIVIDUAL, ASSOCIATION, SOCIETY OR CORPORATION OR FROM THE UNITED STATES GOVERNMENT, OR ANY AUTHORIZED BRANCH, BOARD, COMMISSION, BUREAU, AGENCY, DIVISION, SUBDIVISION OR DEPARTMENT. ANY FUNDS ACCEPTED BY THE UNIVERSITY SHALL BE DEPOSITED IN A NONBUDGETED ACCOUNT UNDER THE STATE TREASURY DEPARTMENT. THESE FUNDS MAY BE INVESTED AS DESIRED BY THE BOARD WITHIN THE LIMITS PERMITTED BY STATE LAW.

IN ORDER TO PROVIDE ADDITIONAL PACILITIES FOR THE PUBLIC COLLEGES UNDER ITS CONTROL, THE BOARD OF MORGAN STATE UNIVERSITY MAY:

- (1) CONSTRUCT, EQUIP, MAINTAIN, REPAIR AND OPERATE ONE OR MORE HOUSING UNITS FOR STUDENTS, BOTH GRADUATE AND UNDERGRADUATE, AT EACH OF THE PUBLIC COLLEGES UNDER ITS DIPECTION AND CONTROL;
- (2) ISSUE REVENUE BONDS OF THE BOARD FOR THE PURPOSE OF PAYING ALL OR ANY PART OF THE COST OF ANY ONE OR MORE HOUSING UNITS;
- (3) FIX AND REVISE, FEES, RENTS AND OTHER CHARGES FOR THE USE OF THE HOUSING UNITS;
