- [[(E)]](D) AFTER ACQUISITION OF THE INITIAL SITE, TO ACQUIRE AND HOLD, AT NO COST TO THE STATE, OTHER REAL AND PERSONAL PROPERTY, OR ANY INTEREST IN IT, BY LEASE, GIFT, PURCHASE, DEVISE, BEQUEST, OR BY ANY OTHER MEANS, AND TO CONSERVE, IMPROVE, ADMINISTER, INVEST, OR DISPOSE OF THOSE PROPERTIES FOR THE PURPOSES AND OBJECTIVES OF THE COMMISSION.
- [[(F)]] (E) TO ACCEPT GIFTS, GRANTS, LEGACIES, BEQUESTS, DEVISES, FEES AND ENDOWMENTS FOR ANY PURPOSE WHICH FALLS WITHIN THAT OF THE PURPOSES AND OBJECTIVES OF THE COMMISSION, UNLESS OTHERWISE SPECIFIED BY THE PERSON MAKING THE GIFT, GRANT, LEGACY, BEQUEST, DEVISE, ENDOWNENT, THE TRUSTEES MAY EXPEND BOTH PRINCIPAL AND INCOME OF ANY GIFT, GRANT, LEGACY, BEQUEST, DEVISE, ENDOWNENT OF MONEY OR INVEST THEM IN WHOLE OR IN PART IN GENERAL OBLIGATIONS OF THE STATE OR OTHER SECURITIES.
