

(C) THE BOARD OR ITS AUTHORIZED INSPECTOR MAY EXAMINE ANY BARBERSHOP AT ANY TIME DURING NORMAL WORKING HOURS TO DETERMINE ITS SANITARY CONDITION. IF AN UNSANITARY CONDITION IS FOUND, THE BOARD SHALL PROMPTLY NOTIFY THE STATE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, WHICH SHALL INITIATE CORRECTIVE ACTION.

(D) THE BOARD OR ITS AUTHORIZED INSPECTOR SHALL INSPECT EVERY NEW BARBERSHOP PRIOR TO ITS OPENING FOR BUSINESS, OR PRIOR TO ITS CHANGING PROPRIETORSHIP OR LOCATION. A BARBERSHOP SHALL BE LOCATED AND EQUIPPED TO MEET REQUIREMENTS OF THE BOARD, THE STATE DEPARTMENT OF HEALTH AND MENTAL HYGIENE, AND LOCAL ZONING CODES. THE REMODELING AND REOPENING OF A PREVIOUSLY EXISTING BARBERSHOP UNDER THE SAME PROPRIETORSHIP IS NOT CONSIDERED A NEW SHOP FOR THE PURPOSES OF THIS SECTION. THE BOARD MAY ASSESS FEES FOR INSPECTION IN ACCORDANCE WITH THIS SUBTITLE. A SHOP MAY NOT OPEN UNLESS THE INSPECTION IS CONDUCTED AND THE FEE PAID.

313.

(A) WITHIN THE MEANING OF THIS SUBTITLE, THE PRACTICING OF THE OCCUPATION OF A BARBER INCLUDES, BUT IS NOT LIMITED TO, SHAVING, TRIMMING THE BEARD, CUTTING AND RAZOR CUTTING, STYLING, RELAXING, BODY WAVING, SHAMPOOING, HAIR COLORING, FACIAL MASSAGING, DESIGNING, FITTING AND CUTTING OF HAIR PIECES FOR HIRE OR REWARD RECEIVED BY THE PERSON PERFORMING THE SERVICE. THESE ACTIVITIES SHALL BE PERFORMED BY A DULY LICENSED BARBER OR IN A DULY LICENSED BARBERING SCHOOL EXCEPT IF, IN THE DISCRETION OF THE BOARD, SPECIAL CIRCUMSTANCES MERIT EXEMPTION. THIS SECTION MAY NOT BE CONSTRUED AS A LIMITATION OR RESTRICTION UPON THE SERVICES WHICH LICENSED COSMETOLOGISTS ARE PERMITTED TO PERFORM PURSUANT TO THE PROVISIONS OF THIS ARTICLE.

(B) THIS SECTION DOES NOT APPLY TO MERE SALES OF WIGS OR HAIRPIECES.

(C) IT IS UNLAWFUL FOR ANY PERSON TO PRACTICE THE OCCUPATION OF BARBERING UNLESS DULY LICENSED UNDER THE PROVISIONS OF THIS SUBTITLE.

(A) ANY PERSON WHO HAS COMPLETED 18 MONTHS' WORK AS A JOURNEYMAN BARBER MAY MAKE APPLICATION TO THE BOARD FOR A CERTIFICATE AS A MASTER BARBER. UPON PAYMENT OF AN EXAMINATION FEE AND RECEIPT OF A PASSING GRADE ON THE MASTER BARBER'S EXAMINATION, A PERSON SHALL BE ENTITLED, WITHOUT LIMITATION, TO DO BARBERING WORK AS DEFINED IN THIS SUBTITLE.
