

(B) THE BOARD SHALL ISSUE A CERTIFICATE OF REGISTRATION TO EACH PERSON QUALIFIED AS A MASTER BARBER. A MASTER BARBER SHALL POST THE CERTIFICATE IN A CONSPICUOUS PLACE IN THE SHOP WHERE HE IS PRACTICING.

[[(C) ANY MASTER BARBER WHO FAILS TO RENEW HIS CERTIFICATE FOR A PERIOD OF FIVE CONSECUTIVE YEARS IS REQUIRED TO PASS THE MASTER BARBER'S PRACTICAL EXAMINATION PRIOR TO ISSUANCE OF A CERTIFICATE.]]

(C) ANY MASTER BARBER WHO FAILS TO RENEW HIS CERTIFICATE FOR A PERIOD OF FIVE CONSECUTIVE YEARS IS REQUIRED TO PASS THE MASTER BARBER'S PRACTICAL EXAMINATION PRIOR TO ISSUANCE OF A CERTIFICATE.

(A) UPON PAYMENT OF THE LICENSE FEE, ANY PERSON WHO HAS SUCCESSFULLY COMPLETED NOT LESS THAN 1,200 HOURS OF INSTRUCTION AT A LICENSED BARBER SCHOOL, AND WHO HAS PASSED THE JOURNEYMAN'S EXAMINATION, SHALL BE ISSUED A JOURNEYMAN BARBER'S LICENSE BY THE BOARD. THE JOURNEYMAN BARBER'S INITIAL LICENSE SHALL BE VALID FOR A PERIOD OF 18 MONTHS AT WHICH TIME THE JOURNEYMAN BARBER SHALL TAKE THE EXAMINATION FOR THE MASTER BARBER'S CERTIFICATE. IF THE JOURNEYMAN BARBER FAILS TO SUCCESSFULLY COMPLETE THE EXAMINATION, THE JOURNEYMAN BARBER'S LICENSE MAY BE RENEWED ANNUALLY.

(B) A JOURNEYMAN BARBER MAY DO BARBERING WORK IN A REGULARLY OPERATED BARBERSHOP UNDER THE SUPERVISION OF A MASTER BARBER [[FOR A PERIOD NOT TO EXCEED 104 WEEKS]].

UPON PAYMENT OF THE FEE, AND PRIOR TO ATTENDING A BARBER SCHOOL, A PROSPECTIVE STUDENT SHALL BE ISSUED A BARBER SCHOOL STUDENT'S PERMIT BY THE BOARD. THE PERMIT AUTHORIZES A STUDENT TO ATTEND BARBER SCHOOL AND RECEIVE NOT LESS THAN 1,200 HOURS OF THEORY AND PRACTICAL INSTRUCTION. THE PERMIT SHALL ALSO AUTHORIZE THE STUDENT TO PERFORM BARBERING WORK ONLY AT THE SCHOOL, FOR WHICH HE MAY NOT RECEIVE REMUNERATION.

AN OWNER OF BARBERSHOP SHALL OBTAIN A LICENSE AND SHALL PAY AN ANNUAL LICENSE FEE FOR EACH BARBERSHOP LOCATION OWNED.

ANY PERSON WHO HAS HAD A MASTER BARBER'S LICENSE FOR FIVE YEARS PRIOR TO APPLICATION, IS OF GOOD MORAL
