CHAPTER 586

(Senate Bill 408)

AN ACT concerning

Baltimore City - Adjustment of Assessments

FOR the purpose of requiring [[in Baltimore City that the assessment pertaining to property acquired for municipal use be decreased or abated as of a specified date regardless of the date of finality; and adding lettering as appropriate.]] the abatement or decrease of real property taxes on property which is acquired by the State or a local government, and providing for apportionment and payment of taxes upon settlement for this property.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section 67 of Article 81 - Revenue and Taxes, of the Annotated Code of Maryland (1969 Replacement Volume and 1974 Supplement) be and it is hereby repealed and re-enacted, with amendments, to read as follows:
