LOAN ASSOCIATIONS OR BUILDING AND LOAN ASSOCIATIONS shall only be made if the bank OR SAVINGS AND ASSOCIATIONS OR BUILDING AND LOAN ASSOCIATIONS deposited a like amount of bonds in escrow, as prescribed by law, covering bank deposits, SAVINGS AND LOAN DEPOSITS, BUILDING AND LOAN DEPOSITS, or if the bank, SAVINGS AND LOAN ASSOCIATION OR BUILDING AND LOAN ASSOCIATION has given as security for these deposits any of the types of collateral set forth in § 21A of this The interest or income from any such investment article. or deposit shall be and become a part of the fund from which the investment or deposit was made and may itself be so invested or deposited, provided, however, that where the fund so invested, or deposited constitutes the proceeds of the issue of bonds or other obligations, the principal of and/or interest on which the issuer is obligated to repay to the holders thereof, the interest income from such investments may be used to pay the principal and/or interest on the same by the issuer. Investments or deposits made pursuant to this section may be withdrawn or altered from time to time by the investing or depositing officer or governing body either to meet the requirements for which such funds are held or for reinvestment pursuant to the terms hereof.

All such investments made prior to March 2, 1943, are hereby legalized, validated, ratified and confirmed, notwithstanding the absence of statutory authority therefor or any inconsistent provision of law.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1975.
