three hundred dollars annually for traveling and other expenses.]

SECTION 2. AND BE IT FURTHER ENACTED, That new Section 37 be and it is hereby added to Article 77 — Public Education, of the Annotated Code of Maryland (1969 Replacement Volume and 1974 Supplement) to read as follows:

Article 77 - Public Education

- 37. MEETINGS; OFFICERS; EXPENSES
- (A) (1) THE COUNTY BOARDS OF EDUCATION SHALL HOLD AN ANNUAL MEETING ON OR AS NEAR AS POSSIBLE TO THE SECOND TUESDAY IN JULY.
- (2) IN MONTGOMERY COUNTY THE ANNUAL MEETING SHALL BE HELD ON OR BEFORE JANUARY 10.
- (3) IN PRINCE GEORGE'S COUNTY THE ANNUAL MEETING SHALL BE HELD AS PROVIDED IN SECTION 36C(E) OF THIS ARTICLE.
- (B) AT THE ANNUAL MEETING THE COUNTY BOARD SHALL ELECT ONE OF ITS MEMBERS AS PRESIDENT AND ONE AS VICE-PRESIDENT.
- (C) ADDITIONAL MEETINGS OF THE COUNTY BOARDS MAY BE HELD AS THEIR DUTIES AND BUSINESS REQUIRE.
- (D) (1) ALL FINAL ACTIONS OF COUNTY BOARDS SHALL BE TAKEN AT A PUBLIC MEETING. THE MINUTES OF THESE MEETINGS SHALL BE AVAILABLE TO THE PUBLIC.
- (2) WITH RESPECT TO DELIBERATIONS ON THE FOLLOWING MATTERS, THE COUNTY BOARDS MAY MEET AND DELIBERATE IN EXECUTIVE SESSION:
 - (I) LAND AND SITE ACQUISITIONS
 - (II) PERSONNEL AND LABOR RELATIONS.
- (E) (1) EXCEPT AS PROVIDED BY THIS [[SECTION]] SUBTITLE, THE MEMBERS OF THE COUNTY BOARDS MAY NOT RECEIVE A SALARY OR COMPENSATION. HOWEVER, EACH MEMBER SHALL BE REIMBURSED FOR TRAVELING AND OTHER EXPENSES INCIDENT TO ATTENDANCE AT BOARD MEETINGS AND THE TRANSACTION OF BOARD BUSINESS.
- (2) IN THE FOLLOWING COUNTIES EACH MEMBER OF THE BOARD SHALL RECEIVE ANNUALLY THE AMOUNTS LISTED FOR TRAVELING AND OTHER EXPENSES.
