- (A) THE DIVISION MAY CONTRACT WITH THE APPROVED PRIVATE NONPROFIT AGENCY OR ORGANIZATION FOR THE FURNISHING OF EXTENDED SHELTERED EMPLOYMENT TO THE DISABLED PERSON WHEN IT APPEARS TO THE SATISFACTION OF THE DIVISION THAT A DISABLED PERSON:
 - (1) IS 17 YEARS OLD OR OLDER;
- (2) IS INCAPABLE OF COMPETING IN THE OPEN LABOR MARKET; AND
