

PARAGRAPH (2), OF THE CODE OF ANNE ARUNDEL COUNTY, MARYLAND (1967 EDITION, AS AMENDED) IS HEREBY DESIGNATED AND SHALL BE KNOWN AS URBAN RENEWAL AREA TWO OF ANNE ARUNDEL COUNTY, MARYLAND AS PROVIDED BY BILL NO. 134-73 OF ANNE ARUNDEL COUNTY, MARYLAND, NAMELY:

BEGINNING AT THE INTERSECTION OF THE NORTHEAST LINE OF GEORGIA AVENUE AND THE NORTHWEST LINE OF AN ALLEY, SAID ALLEY BEING IMMEDIATELY NORTHWEST OF AND PARALLEL TO CRAIN HIGHWAY AND RUNNING THENCE SOUTHEASTERLY ALONG THE NORTHEAST LINE OF GEORGIA AVENUE FOR A DISTANCE OF APPROXIMATELY 690 FEET TO THE EAST LINE OF RITCHIE HIGHWAY; THENCE SOUTHEASTERLY THROUGH A CURVE FOR A DISTANCE OF APPROXIMATELY 2,080 FEET ALONG THE EAST LINE OF RITCHIE HIGHWAY TO A POINT; THENCE SOUTHWESTERLY FROM THE AFORESAID POINT FOR A DISTANCE OF APPROXIMATELY 320 FEET TO THE SOUTHEAST LINE OF N STREET; THENCE SOUTHERLY ALONG THE SOUTHEAST LINE OF N STREET FOR A DISTANCE OF APPROXIMATELY 280 FEET TO THE SOUTHWEST LINE OF GREENWAY AVENUE S.W.; THENCE NORTHWESTERLY ALONG THE SOUTHWEST LINE OF GREENWAY AVENUE S.W. FOR A DISTANCE OF APPROXIMATELY 550 FEET TO ITS INTERSECTION WITH THE SOUTHWEST RIGHT-OF-WAY LINE OF THE BALTIMORE AND ANNAPOLIS RAILROAD; THENCE NORTHWESTERLY THROUGH A CURVE ALONG THE SOUTHWEST RIGHT-OF-WAY LINE OF THE BALTIMORE AND ANNAPOLIS RAILROAD FOR A DISTANCE OF APPROXIMATELY 1,800 FEET TO THE NORTHWEST LINE OF OAK LANE N.W.; THENCE NORTHEASTERLY ALONG THE NORTHWEST LINE OF OAK LANE N.W. FOR A DISTANCE OF APPROXIMATELY 630 FEET TO THE NORTHEAST LINE OF MARYLAND AVENUE; THENCE SOUTHEASTERLY ALONG THE NORTHEAST LINE OF MARYLAND AVENUE FOR A DISTANCE OF APPROXIMATELY 240 FEET TO THE NORTHWEST LINE OF AN ALLEY, IMMEDIATELY SOUTHEAST AND PARALLEL TO OAK LANE N.W.; THENCE NORTHEAST ALONG SAID ALLEY FOR A DISTANCE OF APPROXIMATELY 230 FEET TO THE NORTHWEST LINE OF AN ALLEY, SAID ALLEY BEING NORTHWEST OF AND PARALLEL TO CRAIN HIGHWAY; THENCE NORTHERLY ALONG THE AFORESAID ALLEY FOR A DISTANCE OF APPROXIMATELY 610 FEET TO ITS INTERSECTION WITH THE NORTHEAST LINE OF GEORGIA AVENUE AND ITS POINT OF BEGINNING.]]

SECTION 2. AND BE IT FURTHER ENACTED, That the provisions of this Act shall control over erroneous references contained in The Code of Anne Arundel County, Maryland and appropriate changes to reflect the provisions of this Act shall be made in The Code of Anne Arundel County, Maryland as presently codified.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 1975.
