ANY ACTION OF THE BOARDS TAKEN PURSUANT TO OR UNDER COLOR OF THIS SUBTITLE SHALL BE REVIEWABLE AS PROVIDED IN THE ADMINISTRATIVE PROCEDURE ACT.
- (C) THE BOARD MAY REISSUE A LICENSE TO ANY PERSON WHOSE LICENSE HAS BEEN REVOKED, PROVIDED THAT A MAJORITY OF THE ENTIRE BOARD VOTES IN FAVOR OF REISSUANCE. A NEW LICENSE TO REPLACE ANY LICENSE REVOKED, LOST, DESTROYED, OR MUTILATED MAY BE ISSUED SUBJECT TO THE RULES ADOPTED BY THE BOARD, UPON PAYMENT OF A FEE.
