REASONABLE MAN WOULD CONSIDER CONDUCIVE TO SUCH ACTIVITY.

(3) REFUSES OR FAILS TO LEAVE ANY PRIVATE BUSINESS OR COMMERCIAL ESTABLISHMENT WHICH IS OPEN FOR BUSINESS (INCLUDING BUT NOT LIMITED TO LAUNDRIES, EATING ESTABLISHMENTS, NIGHT BANKING FACILITIES), OR PARKING LOT THEREOF, AFTER HAVING BEEN REQUESTED TO SO BY A REGULAR OR SPECIAL OFFICER, (EITHER IN UNIFORM OR WHO IDENTIFIES HIMSELF BY CREDENTIALS), IF THE SURROUNDING CIRCUMSTANCES ARE SUCH AS TO INDICATE TO A REASONABLE MAN THAT SUCH PERSON HAS NO APPARENT LAWFUL BUSINESS OR PURPOSE TO PURSUE AT SUCH PLACE.

(4) REFUSES OR FAILS TO LEAVE ANY PUBLIC BUILDING, GROUNDS, RECREATIONAL AREAS, OR PARKING LOTS THEREOF, UPON BEING REQUESTED TO DO SO BY A REGULAR OR SPECIAL POLICE OFFICER (EITHER IN UNIFORM OR WHO IDENTIFIES HIMSELF BY CREDENTIALS) OR BY A REGULARLY EMPLOYED GUARD, WATCHMAN, OR OTHER AUTHORIZED EMPLOYEE OF THE AGENCY OR INSTITUTION RESPONSIBLE FOR SAID PUBLIC BUILDING, GROUNDS, RECREATIONAL AREAS, OR PARKING LOTS THEREOF, IF THE SURROUNDING CIRCUMSTANCES ARE SUCH TO INDICATE TO A REASONABLE MAN THAT SUCH PERSON HAS NO APPARENT LAWFUL BUSINESS OR PURPOSE TO PURSUE AT SUCH PLACE.

(5) REFUSES OR FAILS TO LEAVE ANY BUILDING OR ADJACENT GROUNDS OF ANY PUBLIC OR PRIVATE LEARNING INSTITUTION, RECREATIONAL AREAS, OR PARKING LOTS THEREOF, UPON BEING REQUESTED TO DO SO BY A REGULAR OR SPECIAL POLICE OFFICER (EITHER IN UNIFORM OR WHO IDENTIFIES HIMSELF BY CREDENTIALS) OR BY ANY AUTHORIZED EMPLOYEE OF SUCH PUBLIC OR PRIVATE LEARNING INSTITUTION, IF THE SURROUNDING CIRCUMSTANCES ARE SUCH TO INDICATE TO A REASONABLE MAN THAT SUCH PERSON HAS NO APPARENT LAWFUL BUSINESS OR PURPOSE TO PURSUE AT SUCH PLACE, PROVIDED, HOWEVER, THAT THERE IS NO VIOLATION OF THIS SUBSECTION BY ANY PERSON WHO:

(I) IS PRESENT BECAUSE HE HAS CUSTODY OF, OR A RESPONSIBILITY FOR A PUPIL OR STUDENT; OR

(II) IS PRESENT FOR ANY OTHER REASON ASSOCIATED WITH THE PURPOSE OF SUCH INSTITUTION, INCLUDING THE USE OF RECREATIONAL AREAS OR FACILITIES WHEN PERMITTED; OR

(III) DISPLAYS WRITTEN PERMISSION FROM THE PRINCIPAL OR HEAD OF THE INSTITUTION OR HIS DESIGNEE.

(B) NOTHING IN THIS SECTION SHALL BE DEEMED TO PREVENT [[ORDERLY]] LAWFUL picketing or orderly demonstrations by LABOR UNIONS AND/OR members of the public.
