AN ORDINANCE to repeal Section 1-216.2(a) of the Anne Arundel County Code (1967 Edition and Supplements), Title 1, "Administration", Subtitle 2, "Personnel", Article II, "Classified Service", and to enact new Section 1-216.2(a) in lieu thereof, to stand in the place of the section repealed, increasing the compensation of certain County employees within the Public Safety Pay Schedule.

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF ANNE ARUNDEL COUNTY, MARYLAND, That Section 1-216.2(a) of the Anne Arundel County Code (1967 Edition and Supplements), Title 1, "Administration", Subtitle 2, "Personnel", Article II, "Classified Service", be and it is hereby repealed, and that new Section 1-216.2(a) be and it is hereby enacted in lieu thereof, to stand in the place of the section repealed, and to read as follows:
