

COUNTY LOCAL LAWS

THE LIABILITY.

(7) A LIST OF ALL MEMBERS OF THE IMMEDIATE FAMILY OF THE PERSON MAKING THE STATEMENT REQUIRED BY THIS ARTICLE WHO ARE EMPLOYED BY THE COUNTY IN ANY CAPACITY, FOR THE PURPOSE OF THIS PARAGRAPH, THE TERM "IMMEDIATE FAMILY" INCLUDES ONLY SPOUSE AND DEPENDENT CHILDREN.

(8) SUCH ADDITIONAL INTERESTS OR INFORMATION AS THE PERSON MAKING THE STATEMENT MIGHT DESIRE.

(B) THE STATEMENT REQUIRED TO BE FILED BY THOSE PERSONS SET FORTH IN SECTION 9-4(B) SHALL CONTAIN DISCLOSURE OF OWNERSHIP, OR ANY FUTURE INTEREST IN REAL PROPERTY, INTEREST IN ANY LEGAL ENTITY WHICH DOES BUSINESS WITH THE COUNTY, AND ANY OTHER MATTER OR FACT DEEMED PERTINENT OR ADVISABLE AS RECOMMENDED BY THE FINANCIAL DISCLOSURE ADVISORY BOARD.

SEC. 9-7. INTERESTS ATTRIBUTABLE TO PERSON MAKING STATEMENT

FOR THE PURPOSES OF SUBSECTION 9-6 (A) (1) (2) AND (3) AND THE DISCLOSURES THEREIN REQUIRED, THE FOLLOWING SHALL BE CONSIDERED TO BE THE INTERESTS OF THE PERSON MAKING THE STATEMENT:

(A) ANY INTEREST HELD BY THE SPOUSE OR A CHILD OF THE PERSON MAKING THE STATEMENT, IF SUCH INTEREST WAS AT ANY TIME DURING THE YEAR FOR WHICH THE STATEMENT IS FILED DIRECTLY OR INDIRECTLY CONTROLLED BY THE PERSON MAKING THE STATEMENT.

(B) ANY INTEREST HELD BY A BUSINESS ENTITY, IN WHICH BUSINESS ENTITY A THIRTY PERCENT (30%) OR GREATER EQUITY INTEREST WAS AT ANY TIME DURING THE YEAR FOR WHICH THE STATEMENT IS FILED AN INTEREST OF THE PERSON MAKING THE STATEMENT.

(C) ANY INTEREST HELD BY A TRUST, OTHER THAN A COMMON TRUST FUND, UNDER WHICH TRUST THE PERSON MAKING THE STATEMENT HELD A REVERSIONARY INTEREST AT ANY TIME DURING THE YEAR FOR WHICH THE STATEMENT IS FILED, OR UNDER WHICH TRUST THE PERSON MAKING THE STATEMENT WAS AT ANY TIME DURING THAT YEAR A TRUSTOR, IF A REVOCABLE TRUST, OR A BENEFICIARY.

SEC. 9-8. FINANCIAL DISCLOSURE ADVISORY BOARD

(A) THERE IS HEREBY ESTABLISHED THE FINANCIAL DISCLOSURE ADVISORY BOARD. IT SHALL CONSIST OF THREE MEMBERS, TWO OF WHICH SHALL BE APPOINTED BY THE COUNTY EXECUTIVE AND ONE OF WHICH SHALL BE APPOINTED BY [THE
