MONTGOMERY COUNTY

AFTER SUCH LICENSE HAS EXPIRED OR HAS BEEN REVOKED OR SUSPENDED.

23A-10. APPLICATION PROCEDURE.

- (A) A PERSON APPLYING FOR A GROUP RESIDENTIAL CARE PROGRAM LICENSE SHALL FURNISH, ON A FORM APPROVED BY THE DIRECTOR THE NAME OF THE INDIVIDUAL OR ORGANIZATION WHO WILL OPERATE THE FACILITY AS LICENSEE; ADDRESS OF THE PREMISES WHERE THE GROUP RESIDENTIAL CARE PROGRAM IS TO BE CONDUCTED; THE MAXIMUM NUMBER OF PERSONS, INCLUDING STAFF AND EXCEPTIONAL PERSONS, WHO WILL RESIDE AT SUCH PREMISES AT ANY ONE TIME; THE NAME AND ADDRESS OF THE STAFF DIRECTOR DESIGNATED FOR SAID FACILITY; AND SUCH OTHER INFORMATION AS MAY BE REQUIRED BY THE DIRECTOR TO ENSURE THE ATTAINMENT OF THE OBJECTIVES AND PURPOSES OF THIS CHAPTER.
- (B) A SEPARATE LICENSE SHALL BE REQUIRED FOR EACH GROUP CARE FACILITY LICENSED IN ACCORDANCE WITH PROVISIONS OF THIS CHAPTER.
- (C) APPLICANTS FOR LICENSES AND RENEWALS THEREOF SHALL PAY TO MONTGOMERY COUNTY, HARYLAND A FEE TO BE ESTABLISHED AND REVISED FROM TIME TO TIME BY THE COUNTY EXECUTIVE OF AN AMOUNT NOT TO EXCRED THE COST OF ADMINISTERING AND ENFORCING THE PROGRAM.

23A-11. TERMS OF LICENSES.

- (A) EACH LICENSE ISSUED HEREUNDER SHALL BECOME NULL AND VOID UPON THE RELOCATION OF ANY GROUP RESIDENTIAL CARE PROGRAM FROM THE FACILITY DESIGNATED IN SAID LICENSE. ANY SUCH LICENSEE SHALL, BEFORE CHANGING THE LOCATION OF ITS PROGRAM MAKE APPLICATION FOR A NEW PROGRAM LICENSE TO THE DEPARTMENT.
- (B) NO LICENSE ISSUED HEREUNDER SHALL BE TRANSPERABLE.
- (C) RENEWAL OF LICENSES. SUBJECT TO THE AUTHORITY SET FORTH IN SECTION 23A-13 OF THIS CHAPTER, LICENSES ISSUED HEREUNDER SHALL EXPIRE ON JUNE 30 ON EACH YEAR AND RENEWALS THEREAFTER SHALL BE EFFECTIVE JULY 1 THROUGH JUNE 30 OF EACH YEAR WITH RENEWAL APPLICATIONS BEING MADE NOT LESS THAN SIXTY (60) DAYS PRIOR TO THE EXPIRATION DATE THEREON.

23A-12. FUNCTION AND PROCEDURES.
