LICENSE IS NOT AT THE TIME OF THE SUCH APPLICATION BONDED AS A MASTER ELECTRICIAN. IN THE EVENT THAT THE APPLICANT IS BONDED AS A MASTER ELECTRICIAN LIMITED HE SHALL ADDITIONAL CASH OR CORPORATE BOND IN THE DELIVER AN AMOUNT OF \$1,000.00. ANY CORPORATE BOND DELIVERED TO THE COUNTY PURSUANT TO THIS SECTION SHALL BE EXECUTED BY SURETY OR GUARANTY COMPANY QUALIFIED TO TRANSACT BUSINESS IN MARYLAND. ANY SUCH BOND SHALL EXPIRE ON THE THIRTIETH DAY OF JUNE NEXT FOLLOWING THE DATE SUCH BOND WAS A LICENSEE WITH A MASTER ELECTRICIAN'S OR EXECUTED. MASTER ELECTRICIAN'S LIMITED LICENSE WHO IS THE REGULAR EMPLOYEE OF A PLANT, FACTOR, APARTMENT, OR OTHER FACILITY MAINTENANCE PERSONNEL AND WHO PERFORMS NO EMPLOYING ELECTRICAL WORK FOR THE PUBLIC SHALL NOT BE REQUIRED TO BE BONDED UNDER THIS SECTION. THE BOND SHALL RUN TO THE COUNTY AND SHALL BE CONDITIONED THAT THE LICENSEE SHALL PERFORM ALL WORK DONE BY HIM, HIS AGENT, AND EMPLOYEES IN THIS COUNTY IN ACCORDANCE WITH THE COUNTY ELECTRICAL CODE.

- (F) AN APPLICANT FOR A BUSINESS LICENSE SHALL PURNISH A CERTIFICATE FROM AN INSURANCE COMPANY QUALIFIED TO DO BUSINESS IN THE STATE OF MARYLAND OF PUBLIC LIABILITY INSURANCE IN THE AMOUNT OF \$25,000.00 COVERAGE DEATH OR PERSONAL INJURY OF ONE INDIVIDUAL: \$100,000.00 COVERAGE FOR DEATH OR PERSONAL INJURY OF TWO OR HORE INDIVIDUALS AND \$25,000.00 COVERAGE FOR PROPERTY DANAGE, WHICH INSURANCE WHALL PROVIDE COVERAGE FOR DONE UNDER ANY PERHIT ISSUED HEREUNDER BY MONTGOMERY COUNTY, MARYLAND AND SHALL INCLUDE COVERAGE FOR PREMISES OPERATIONS AND COMPLETED OPERATIONS. LIABILITY INSURANCE SHALL STATE THAT THE COVERAGE THEREIN PROVIDED FOR SHALL REMAIN IN FULL FORCE AND EFFECT UNTIL DAYS FOLLOWING THE DATE WRITTEN NOTICE OF THIRTY CANCELLATION OR FAILURE TO RENEW IS GIVEN BY INSURANCE CARRIER OR ITS AUTHORIZED AGENT TO MONTGOMERY COUNTY AND ANY CERTIFICATE OF INSURANCE PURSUANT TO THIS SECTION SHALL PROVIDE FOR SUCH COVERAGE.
- (G) SUBJECT TO THE PROVISIONS CONTAINED IN SECTION 17-24, EACH LICENSE AND RENEWAL OF SAME SHALL BE IN FORCE AND EFFECT ONLY AS LONG AS THE APPROVED BOND AND INSURANCE CERTIFICATES THAT HAVE BEEN FILED WITH THE BOARD, IN ACCORDANCE WITH THE PROVISIONS OF THIS SECTION, SHALL REMAIN IN FULL FORCE AND EFFECT. EVERY SUCH LICENSE OR RENEWAL OF SAME SHALL BECOME VOID AND OF NO EFFECT SHOULD ANY SUCH BOND OR INSURANCE CONTRACT BECOME INOPERATIVE, INEFFECTIVE OR CANCELLED, REGARDLESS OF THE REGULAR DATE OF EXPIRATION OF SAID LICENSE.
