## COUNTY LOCAL LAWS

- THE MONTGOMERY COUNTY RECREATION BOARD SHALL COORDINATE THE EFFORTS AND ACTIVITIES OF THE RECREATION AREA ADVISORY BOARDS AND SHALL HAVE THE FOLLOWING COUNTY—WIDE DUTIES AND RESPONSIBILITIES:
- (A) STUDY THE RECREATION SERVICES AND NEEDS OF MONTGOMERY COUNTY.
- (B) ACT IN AN ADVISORY CAPACITY TO THE DIRECTOR OF RECREATION, THE COUNTY EXECUTIVE AND THE COUNTY COUNCIL IN MATTERS RELATING TO RECREATION POLICIES AND SERVICES.
- (C) ASSIST IN DEVELOPING AND MAINTAINING COOPERATIVE RELATIONSHIPS WITH THE BOARD OF EDUCATION, THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION, AND THE VARIOUS VOLUNTARY AGENCIES WITHIN THE COUNTY IN MATTERS AFFECTING RECREATION PROGRAMS AND SERVICES.
- (D) INTERPRET RECREATION POLICIES AND PROGRAMS TO THE COUNTY COUNCIL AND TO THE PUBLIC.
- (E) RECOMMEND TO THE DIRECTOR ITEMS THE BOARD BELIEVES SHOULD BE INCLUDED IN THE BUDGET.
- (F) REVIEW PLANS FOR NEW FACILITIES AND MAKE RECOMMENDATIONS TO THE DIRECTOR CONCERNING THEM.
- (G) APPEAR AT SPECIAL DEPARTMENT OF RECREATION FUNCTIONS AND VISIT RECREATIONAL PROGRAMS AND ACTIVITIES FROM TIME TO TIME.
- 41-23. SAME OFFICERS; BY-LAWS; MEETINGS; QUORUM; COMPENSATION.
- (A) THE CHAIRMAN AND VICE—CHAIRMAN OF THE RECREATION BOARD SHALL BE APPOINTED BY THE COUNTY EXECUTIVE, SUBJECT TO CONFIRMATION BY THE COUNTY COUNCIL. IN MAKING THESE APPCINTMENTS, THE COUNTY EXECUTIVE SHALL CONSIDER RECOMMENDATIONS FROM THE RECREATION AREA ADVISORY BOARDS. THE RECREATION BOARD IS AUTHORIZED TO ELECT OTHER OFFICERS, TO ESTABLISH COMMITTEES OF ITS MEMBERS, AND TO ADOPT BY—LAWS AND RULES AND REGULATIONS FOR THE CONDUCT OF ITS AFFAIRS AS IT DEEMS DESIRABLE.
- (B) THE RECREATION BOARD SHALL MEET IN PUBLIC SESSION ON CALL BY THE CHAIRMAN AS FREQUENTLY AS NECESSARY TO PERFORM ITS DUTIES, BUT NOT LESS THAN ONCE EACH QUARTER OF ANY CALENDAR YEAR. REASONABLE NOTICE SHALL BE GIVEN FOR ALL MEETINGS OF THE BOARD. A MAJORITY OF THE MEMBERS OF THE BOARD SHALL CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS, AND A MAJORITY VOTE OF THOSE PRESENT AT ANY MEETING SHALL BE REQUIRED FOR ANY ACTION
