

## MONTGOMERY COUNTY

REFLECT A WIDE DIVERSITY OF RECREATIONAL INTERESTS IN ORDER THAT THE DUTIES OF THE BOARD MAY BE ADEQUATELY PURSUED IN LIGHT OF THE PURPOSES OF THIS ARTICLE. DUE CONSIDERATION SHALL BE GIVEN TO GEOGRAPHICAL REPRESENTATION FROM DIFFERENT NEIGHBORHOOD CENTERS IN THE RECREATION AREA. THE TERMS OF FOUR (4) OF THE MEMBERS INITIALLY CONFIRMED SHALL BE FOR ONE (1) YEAR, AND THE TERMS OF THE REMAINING THREE (3) MEMBERS FIRST CONFIRMED SHALL BE FOR TWO (2) YEARS, AS PRESCRIBED BY THE COUNTY EXECUTIVE AT THE TIME OF APPOINTMENT. SUBSEQUENT TO THESE INITIAL APPOINTMENT TERMS, THE TERMS OF THE MEMBERS SHALL BE TWO (2) YEARS OR UNTIL THEIR SUCCESSORS ARE CONFIRMED. NO BOARD MEMBER SHALL SERVE CONSECUTIVELY FOR MORE THAN FOUR (4) YEARS. A VACANCY OCCURRING PRIOR TO THE EXPIRATION OF THE TERM FOR WHICH A MEMBER OF A BOARD IS CONFIRMED SHALL BE FILLED IN THE SAME MANNER AS PROVIDED HEREIN FOR THE REMAINDER OF THE UNEXPIRED TERM OF THE PREDECESSOR.

(B) EACH MUNICIPALITY WHICH HAS WITHIN A DESIGNATED RECREATION AREA AN ACTIVE RECREATION PROGRAM MAY DESIGNATE A REPRESENTATIVE OR REPRESENTATIVES TO SERVE AS EX-OFFICIO MEMBERS OF THE RECREATION AREA ADVISORY BOARD FOR THAT AREA.

(C) THE MEMBERS OF EACH BOARD SHALL SERVE WITHOUT COMPENSATION UNLESS THE COUNTY COUNCIL SHALL, BY RESOLUTION, FROM TIME TO TIME FIX A RATE OF COMPENSATION. MEMBERS SHALL, HOWEVER, BE REIMBURSED FOR ALL ACTUAL EXPENSES NECESSARILY INCURRED IN THE PERFORMANCE OF THEIR DUTIES IN ACCORDANCE WITH APPROPRIATIONS MADE THEREFOR BY THE COUNTY COUNCIL. THE DEPARTMENT OF RECREATION SHALL DESIGNATE A STAFF EMPLOYEE TO SERVE AS AN ADVISOR TO EACH BOARD, AND THE DIRECTOR OF THE DEPARTMENT SHALL REQUEST THAT REPRESENTATIVES FROM THE BOARD OF EDUCATION AND THE PARK AND PLANNING COMMISSION BE PRESENT AT MEETINGS OF EACH BOARD.

41-28. SAME - CHAIRMEN VICE-CHAIRMEN; ELECTION; TERM.

A CHAIRMAN AND A VICE-CHAIRMAN SHALL BE ELECTED BY EACH RECREATION AREA ADVISORY BOARD FROM AMONG ITS MEMBERS. THE TERM OF THE CHAIRMAN AND THE VICE-CHAIRMAN SHALL BE ONE (1) YEAR, AND EACH SHALL BE ELIGIBLE FOR RE-ELECTION FOR AN ADDITIONAL ONE-YEAR TERM. NO CHAIRMAN OR VICE-CHAIRMAN SHALL SERVE CONSECUTIVELY FOR MORE THAN TWO (2) YEARS. THE CHAIRMAN AND VICE-CHAIRMAN OF EACH RECREATION AREA ADVISORY BOARD SHALL ALSO SERVE AS MEMBERS OF THE COUNTY RECREATION BOARD ESTABLISHED PURSUANT TO SECTION 41-21 OF THIS ARTICLE.
