REFLECT A WIDE DIVERSITY RECREATIONAL INTERESTS OF THE BOARD MAY BE ADEQUATELY OF THAT THE DUTIES PURSUED IN LIGHT OF THE BURBOSES OF THIS ARTICLE. DUE TO GIVEN CONSIDERATION SHALL BE GEOGRAPHICAL REPRESENTATION PROM DIFFERENT NEIGHBORHOOD CENTERS IN THE THE TERMS OF FOUR (4) OF THE MEMBERS RECREATION AREA. CONFIRMED SHALL BE FOR ONE (1) YEAR, AND THE INITIALLY TERMS OF THE REMAINING THREE (3) MEMBERS FIRST CONFIRMED SHALL BE FOR TWO (2) VEARS, AS PRESCRIBED BY THE COUNTY EXECUTIVE AT THE TIME OF APPOINTMENT. SUBSEQUENT TO THESE INITIAL APPOINTMENT TERMS, THE TERMS OF THE MEMBERS (3) YEARS OR HWELL THEIR SUCCESSORS ARE BE THO CONFIRMED. NO BOARD MEMBER SHALL SERVE CONSECUTIVELY FOR HORE THAN FOUR (4) YEARS, A VACANCY OCCURRING PRIOR TO THE EXPIRATION OF THE TERM FOR WHICH A MEMBER OF A BOARD IS CONFIRMED SHALL BE FILLED IN THE SAME MANNER AS PROVIDED HEREIN FOR THE RENAINDER OF THE UNEXPIRED TERM OF THE PREDECESSOR.

- (B) BACH MUNICIPALITY WHICH HAS WITHIN A DESIGNATED RECEBATION AREA AN ACTIVE RECREATION PROGRAM MAY DESIGNATE A REPRESENTATIVE OR REPRESENTATIVES TO SERVE AS EX-OFFICIO MEMBERS OF THE RECREATION AREA ADVISORY BOARD FOR THAT AREA.
- THE MEMBERS OF EACH BOARD SHALL SERVE COMPRESATION UNLESS THE COUNTY COUNCIL SHALL, BY WITHOUT RESOLUTION, FROM TIME TO TIME FIX A RATE OF COMPENSATION. MEMBERS SHALL, HOWEVER, BE REIMBURSED FOR ALL ACTUAL EXPENSES NECESSARILY INCURRED IN THE PERFORMANCE OF THEIR DUTIES IN ACCORDANCE WITH APPROPRIATIONS MADE THEREFOR BY THE DEPARTMENT OF RECREATION SHALL COUNTY COUNCIL. DESIGNATE A STAFF EMPLOYEE TO SERVE AS AN ADVISOR TO EACH BOARD, AND THE DIRECTOR OF THE DEPARTMENT SHALL REQUEST REPRESENTATIVES FROM THE BOARD OF EDUCATION AND THE PARK AND PLANNING COMMISSION BE PRESENT AT MEETINGS OF EACH BOARD.
- 41-28. SAME CHAIRMEN VICE-CHAIRMEN: ELECTION: TERM.
- AND A VICE-CHAIRMAN SHALL BE ELECTED BY CHAIRMAN EACH RECREATION AREA ADVISORY BOARD FROM AMONG THE TERM OF THE CHAIRMAN AND THE VICE-CHAIRMAN MEMBERS. SHALL BE ONE (1) YEAR, AND EACH SHALL BE ELIGIBLE FOR RE-ELECTION FOR AN ADDITIONAL ONE-YEAR TERM. NO CHAIRMAN OR VICE-CHAIRMAN SHALL SERVE CONSECUTIVELY FOR MORE THAN TWO (2) YEARS. THE CHAIRMAN AND VICE-CHAIRMAN OF EACH RECREATION AREA ADVISORY BOARD SHALL ALSO SERVE AS MEMBERS OF THE COUNTY RECREATION BOARD ESTABLISHED PURSUANT TO SECTION 41-21 OF THIS ARTICLE.
