FOR MONTGOMERY COUNTY, ON OR BEFORE THE 1ST DAY OF JUNE OF EACH YEAR DURING WHICH THAT PERSON SERVES IN SUCH OFFICE OR POSITION, THE SWORN STATEMENT REQUIRED BY THIS CHAPTER FOR THE CALENDAR YEAR IMMEDIATELY PRECEDING EACH SUCH YEAR IN THAT OFFICE OR POSITION. ANY PERSON APPOINTED TO ANY OFFICES OR POSITIONS SET FORTH IN SECTION 20 A-3 (B) (10), (12), (13) OR (17), ON OR AFTER THE OF THIS CHAPTER SHALL, WHERE SUCH DATE EFFECTIVE APPOINTMENT IS MADE BY THE COUNTY EXECUTIVE, FILE THE INITIAL STATEMENT REQUIRED BY THIS CHAPTER BEFORE FINAL ACTION IS TAKEN BY THE COUNTY COUNCIL ON THE CONFIRMATION OF SUCH APPOINTMENT. WHERE ANY SUCH APPOINTMENT IS MADE THE COUNTY COUNCIL, THE APPOINTEE SHALL FILE SUCH INITIAL STATEMENT AFTER SELECTION BY THE SUBCOMMITTEE OF THE COUNCIL, OR THE COUNCIL SITTING AS A COMMITTEE OF THE WHOLE, BEFORE THE APPOINTMENT IS SUBMITTED TO THE FULL COUNCIL FOR ACTION. NO SUCH STATEMENT FILED BY ANY APPOINTEE TO A POSITION SET FORTH IN SECTION 20 A-3 (B) (10) SHALL BE HADE PUBLIC UNTIL AFTER FINAL ACTION ON SUCH APPOINTMENT IS COMPLETED.

- (B) EXCEPT FOR A PERSON WHO HAS FILED A STATEMENT PURSUANT TO SUBSECTION (A) ABOVE FOR THE SAME YEAR FOR WHICH A STATEMENT OTHERWISE WOULD BE REQUIRED TO BE FILED BY THIS SUBSECTION, EACH CANDIDATE FOR NOMINATION FOR, OR ELECTION TO, AN OFFICE SET FORTH IN SUBSECTION (A) OF SECTION 20 A-3 ABOVE SHALL FILE WITH THE MONTGOMERY COUNTY BOARD OF SUPERVISORS OF ELECTIONS, AT OR BEFORE THE SAME TIME THAT PERSON'S CERTIFICATE OF CANDIDACY IS FILED, THE STATEMENT REQUIRED BY THIS CHAPTER, FOR THE CALENDAR YEAR IMMEDIATELY PRECEDING THE YEAR IN WHICH THAT CERTIFICATE OF CANDIDACY IS FILED.
- (C) IF A CERTIFICATE OF CANDIDACY IS FILED PRIOR TO JANUARY 1 OF THE YEAR IN WHICH THE ELECTION IS HELD, THE CANDIDATE SHALL, ON OR BEFORE THE LAST DAY FOR THE WITHDRAWAL OF CANDIDACY, FILE A SUPPLEMENTARY STATEMENT FOR THE CALENDAR YEAR IMMEDIATELY PRECEDING THE ELECTION; AND IF THE CANDIDATE FAILS TO DO SO, AFTER WRITTEN NOTICE OF THIS OBLIGATION GIVEN BY THE COUNTY FOARD OF SUPERVISORS OF ELECTIONS AT LEAST 20 DAYS PRIOR TO THE LAST DAY FOR THE WITHDRAWAL OF CANDIDACY, THE CANDIDATE SHALL BE DEEMED TO HAVE WITHDRAWN HIS OR HER CANDIDACY.
- (D) EXCEPT AS PROVIDED IN SUBSECTION (E), THE BOARD OF SUPERVISORS OF ELECTIONS SHALL NOT ACCEPT ANY CERTIFICATE OF CANDIDACY OR CERTIFICATE OF NOMINATION UNLESS A STATEMENT IN PROPER FORM HAS BEEN FILED PURSUANT TO THIS CHAPTER. WITHIN 30 DAYS OF THE RECEIPT OF A STATEMENT BY THE BOARD, THE BOARD SHALL FORWARD THE STATEMENT TO THE CHIEF ADMINISTRATIVE OFFICER FOR RETENTION PURSUANT TO THE PROVISIONS OF THIS CHAPTER.
