

Between the parties aforesaid should be made more manifest unto vs Wee haue in the presence of Christopher Rouby Gentleman and Michael Sawny Attorney of Job Nutt And Henry Jowles and Sybell his Wife Coe of William Groome as aforesaid And Robert Carville Gent: These Attorneys considered the Inueneritie of the matters in difference between the parties aforesaid And haue heard and read the proofes alligations accounts Discompts Charge and discharges which were produced before us and upon the whole matter and serious advice and deliberate Consideration of the Justices Wee doe Order Judge and determine as followeth

First That the said Henry Jowles and Sybell his Wife Coe of William Groome as aforesaid Assigne or assignes and Upon the plantation of the said Job Nutt his Attorney or Attorneys Eighteen Cows fifteen Calves One Bull of foure years old foure Cattle of two years old Cows five Steers of three years old each two Sows two Barrowes one Boare twelve poultry and severall household goods mentioned in a Schedule hereunto annexed At or before the tenth day of January next ensuing the date of these presents And Wee doe further Order Judge and determine that the aforesaid Michael Sawny Attorney of the aforesaid Job Nutt shall upon due Notice Given by the aforesaid Henry Jowles or his order be ready at the aforesaid Plantation of the said Job Nutt to take and receive and every the aforesaid Cattle hogs poultry and household goods soe to be delivered by the said Henry Jowles and Sybell his Wife as to give receipt to the said Henry Jowles and Sybell his Wife for the same

Secondly Wee doe order Judge and determine that the aforesaid Henry Jowles & Sybell his wife Coe of William Groome as aforesaid doe well and truly pay unto the said Job Nutt his Attorney or Attorneys Assigne or assignes the full and Just Summe of eleaven thousand two hundred and five pounds of Tobacco Conveniently in Calvert County at or upon the tenth day of January which shall be in the Year of our Lord One thousand six hundred & twenty nine

Thirdly Wee doe order Judge and determine that the aforesaid Henry Jowles & Sybell his wife Coe of William Groome as aforesaid doe make seal and deliver unto the aforesaid Job Nutt his Attorney and Attorneys Assigne and assignes One good and sufficient Release and discharge of hand from all bargained Covenants Contracts agreements bills bonds Writings and accounts what soever And also from all and all manner of Error or Error What soever in the duties above specified And also that the said Michael Sawny Attorney of the said Job Nutt or other the Attorney or Attorneys of the said Job Nutt for the time being doe upon the performance of all and singular of the orders Judge and determination aforesaid make seal and deliver unto the said Henry Jowles and Sybell his Wife Coe of William Groome as aforesaid One good and sufficient Release and discharge of hand from all bargained Covenants Contracts agreements bills bonds Writings and accounts what soever And also from all and all manner of Error or Error what soever in the duties above specified

And Wee doe further order Judge and determine that the aforesaid Henry Jowles and Sybell his Wife Coe as aforesaid doe at or before the tenth day of January next ensuing the date of these presents deliver up possession unto the said Job Nutt his Attorney or Attorneys Assigne or assignes One plantation called by the name of Nutts (left lying in petuport River with all and singular the houses and Edifices thereunto belonging
